## **BOARD OF DIRECTORS MEETING MINUTES**

#### **MEETING DATE: June 11, 2015**

The Solano County Water Agency Board of Directors met this evening at the Solano County Water Agency. Present were:

## CALL TO ORDER

The meeting was called to order at 6:30 P.M. by Chairman Crossley.

#### APPROVAL OF AGENDA

On a motion by Supervisor Seifert and a second by Director Kluge the Board unanimously approved the agenda.

## PUBLIC COMMENT

Comments were received by Mr. Russ Lester and Mrs. Moira Burke regarding the need for wider publicity and public noticing for the Sustainable Groundwater Management Act stakeholder meetings. Staff informed the Board that only one initial meeting has occurred among known public agency stakeholders and its purpose was primarily to determine how to reach out beyond the known core stakeholders. SCWA is consulting with DWR regarding potential outreach assistance to help identify the breadth of stakeholders and reach out to them for following meetings.

Staff requested Item F be pulled from consent to provide an update. On a motion by Mayor Price and a second by Supervisor Hannigan the Board unanimously approved the following Consent Items:

(H) <u>Purchase from Campbell Scientific of replacement water quality and monitoring</u> <u>equipment for PSC and NBA</u>

(I) Flood Control Advisory Committee Appointment

Staff updated the Board on Consent Item 5F: <u>Mitigated Negative Declaration for the</u> NAWCA 3 – Lower Putah Creek Floodplain Restoration Project.

A comment letter was received on the mitigated negative declaration for the proposed project. The letter was requesting special consideration to avoid impacts to bats. Staff reviewed the issue and determined that the measures were unnecessary and not substantive. None of the bat species present are afforded special protections by State and Federal agencies.

Public comment was received from Mr. Jeff TenPas in opposition of the proposed project. Mr. TenPas provided a written comment letter at the meeting. A motion was made by Supervisor Spering to move Consent Item F to the August Board meeting and a second was made by Supervisor Seifert. Supervisor Vasquez made a substitute motion to adopt Consent Item F with a second by Mayor Batchelor. Upon further deliberation Supervisor Vasquez amended his substitute motion to extend Mr. TenPas's comment period and then for the Board to consider adopting Consent Item 5F after deliberation with a second by Mayor Batchelor. The Board inquired further on the nature of Mr. TenPas's issues during the extended comment period. Staff provided additional details to address Mr. TenPas's concerns.

Upon conclusion of the debate Supervisor Vasquez moved for adoption of the Mitigated Negative Declaration for the NAWCA 3 – Lower Putah Creek Floodplain Restoration Project as recommended by staff with a second by Mayor Batchelor. On an 11 to 2 vote, the Board approved to adopt the Mitigated Negative Declaration for the NAWCA3-Lower Putah Creek Floodplain Restoration Project. Supervisor Seifert and Supervisor Thomson opposed the motion.

## **BOARD MEMBER REPORTS**

Mayor Sanchez inquired about the ability of the Agency's Turf Replacement Program to allow artificial turf. Staff informed the Board that the grant funding source explicitly prohibits acceptance of artificial turf for reimbursement with those funds.

## **GENERAL MANAGER'S REPORT**

There were no additions to the written report.

## SCWA BUDGET FOR FISCAL YEAR 2015-2016

Staff presented to the highlights of the Proposed Budget. The Executive Committee had reviewed the Proposed Budget and their comments incorporated. On a motion by Mayor Batchelor and a second by Supervisor Seifert the Board unanimously adopted the Agency's Fiscal Year 2015-2016 Proposed Budget.

## **BUDGET IMPLEMENTATION ACTIONS**

- (A) On a motion by Supervisor Seifert and a second by Mayor Augustine the Board established a tax rate of \$0.02 per \$100 of assessed valuation for the State Water Project property tax for fiscal year 2015-2016. Mayor Sanchez opposed the motion.
- (B) On a motion by Mayor Richardson and a second by Mayor Batchelor the Board unanimously awarded a 2% cost of living adjustment to Water Agency employees effective the payroll period starting July, 5, 2015.
- (C) On a motion by Supervisor Seifert and a second by Mayor Richardson the Board unanimously authorize the Interim General Manager to execute agreements and amendments for the following consultant services for work through fiscal year 2015 – 2016:

I hope everyone had a pleasant break through the month of July! This will be my last report as your General Manager and it has been my pleasure to serve the Board through the interim period. I thank you for the opportunity and your confidence in me, the experience has been exhilarating!

The word of the summer is "WILDFIRE"! We have had two local events along the Blue Ridge since July 4. The Sky Fire began on July 6 burning 150 acres in Mix Canyon, the headwaters to Ulatis Creek which flows through the City of Vacaville. Due the relatively small size of this fire, we do not expect any significant increased erosion issues into the creek but we will monitor it none the less. The more recent Wragg Fire consumed approximately 8,000 acres along tributaries of Putah Creek between Monticello and Putah Diversion Dams, is now contained. The more impressive Rocky Fire (approximately 70,000 acres, 40% contained) has scorched part of Upper Putah Creek watershed above Lake Berryessa. I will provide a more detailed briefing at the Board meeting.

SCWA, SID, City of Vacaville, and County staff has voluntarily stepped up to initiate the State's Groundwater Management Act's (SGMA) requirement to form a Groundwater Sustainability Agency (GSA) for the Solano Sub-basin by 2017. A Solano Collaborative Groundwater Management Group has begun outreach meetings to identify interested stakeholders in the Solano Sub-basin. Participation in the Group is open to any and all public agencies, private enterprises, and citizens with an interest in groundwater resources of the Solano Sub-basin. The Group has initially established a monthly meeting schedule of the fourth Wednesday of each month to maintain momentum for the process. There have been two meeting thus far and the next is scheduled for Aug 26, 10 AM at the Ulatis Community Center in Vacaville.

Three new alternatives are added, a 15,000 cfs, 9,000 cfs, and 3,000 cfs, facility alternatives with the Section 7 permitting option. These new alternatives are proposing the modified design with the pumps located at the south end of the tunnel. The preferred alternative is the 9,000 cfs facility under Section 7 permitting. Staff will be reviewing the revised documents and provide additional comments as necessary by the October 31 deadline.

Water quality at the NBA has been good; DWR's installation of the single drought barrier at False Slough has not impacted Barker Slough so far. Current storage capacity in Lake Berryessa is 54%.

In the month of July, SCWA staff conducted 513 pre-inspections and 109 post-inspections which included one commercial property (the Comfort Inn, Vallejo). \$74,535 was disbursed in rebates and a total of 86,400 square feet of turf was converted into water-efficient landscaping.

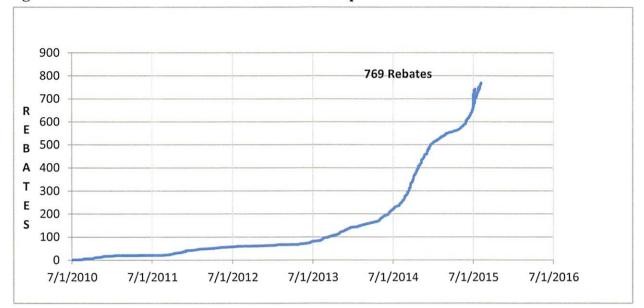
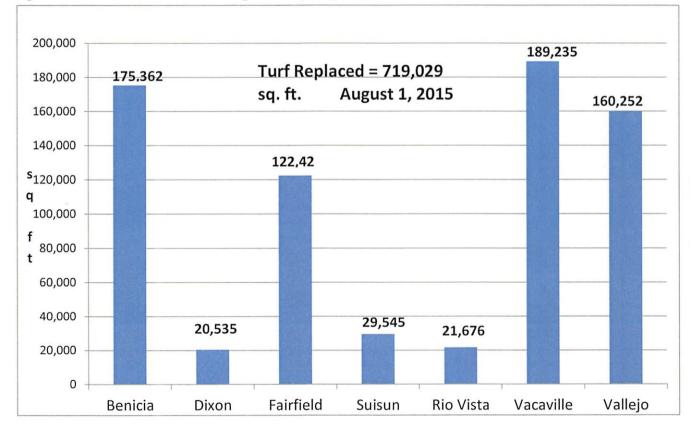
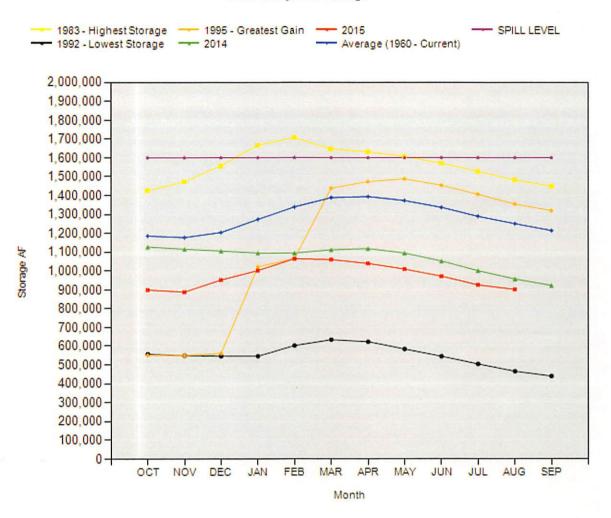


Figure 1. Total Amount of Water Efficient Landscape Rebates 7/1/2010 - 8/1/2015

Since the Water Efficient Landscape (WEL) rebate program began in July, 2010 a total of 769 rebates have been issued, with the vast majority occurring since July 1, 2014 (See Figure 1). A total of 719,029 square feet of turf has been replaced with climate appropriate landscaping.
