BOARD MEMBER REPORTS

There were no Board member reports.

GENERAL MANAGER'S REPORT

In addition to his written report, General Manager Roland Sanford briefed the Board on the status of the Phase I Dixon drainage study and noted that the draft Phase I Dixon Watershed Study report was received shortly after the April Board agenda packet was published, and that a meeting of Water Agency, City of Dixon, Dixon Resource Conservation District, and RD 2068 staff has been scheduled for April 25, 2019 to review the draft report.

Mayor Patterson asked staff to elaborate on the Condition 12 Settlement Agreement referenced in the April General Manager's report. General Manager Roland Sanford explained that Condition 12 is a term in the Solano Project water rights licenses and permit that pertains to water diversions in the Lake Berryessa watershed, upstream of Lake Berryessa, and that the Condition 12 Settlement Agreement adjudicated water rights in the Lake Berryessa watershed and established the Upper Putah Creek Watermaster to monitor compliance with the Condition 12 Settlement Agreement.

SOLANO WATER ADVISORY COMMISSION

There was no verbal report, the minutes of the February 27, 2019, Solano Water Advisory Commission report were included in the Board meeting packet.

(Mayor Wilson joined the Board meeting immediately following the Solano Water Advisory Commission agenda item)

WATER AGENCY STAFFING-SEASONAL MAINTENANCE AIDES

General Manager Roland Sanford commented that he had nothing to add to the written staff summary included in the Board's agenda packet for this item. There were no Board member questions or comments.

On a motion by Mayor Rowlett and a second by Mayor Price, the Board unanimously approved the Water Agency seasonal staffing of maintenance aides.

LEGISLATIVE UPDATES

Supervisor Thomson noted that Mayor Kott will take over as Chair of the Legislative Committee beginning in May. Supervisor Thomson reported that the committee had met the prior week and is recommending the Board support two pending legislative bills AB 533 (Holden)-Income tax exclusion for water conservation rebates, and AB 557 (Wood/Aguiar-Curry)-atmospheric rivers research.

SUBJECT June 2019 General Manager's Report

Water Supply Outlook

As of this writing Lake Berryessa is essentially at 100% capacity, with the water surface elevation just three inches below the lip of the glory hole spillway. The late rains in May, in addition to topping off the lake, blunted spring irrigation demands. In February the Department of Water Resources increased the 2019 North Bay Aqueduct water supply allocation to 85% of the full Table "A" contractual amount. In view of the unusually heavy Sierra snowpack it is possible that the allocation could be increased further – though probably not by much.

Phase I Dixon Watershed Study

The Draft Phase I Dixon Watershed Study report was completed on schedule. Water Agency, City of Dixon, Dixon Resource Conservation District and RD 2068 staff will be meeting shortly to review, discuss and prepare comments on the draft report. It is anticipated that the final report will be completed by the end of June.

Bay-Delta Plan Update/Voluntary Settlement Agreements

Considerable staff time has and at least for the balance of 2019 will continue to be directed toward the Bay-Delta Plan Update and more specifically, participation in the ongoing development of a Voluntary Settlement Agreement (now called the "Voluntary Agreement") that would encompass most of the major tributaries in the Sacramento River drainage, and possibly some tributaries in the San Joaquin River drainage. The effort is being led by State Secretary of Natural Resources Wade Crofoot and State Secretary of CalEPA Jared Blumenfeld, both of whom report to Governor Newsom.

Coordinating the proposed streamflow and physical habitat actions on the individual tributaries, so as to achieve the desired conditions in the Bay-Delta, is an exceedingly challenging technical and political task, and while the outcome remains uncertain, the "Voluntary Agreement pathway" continues to be a far more productive option than prolonged litigation – unless of course you are an attorney.

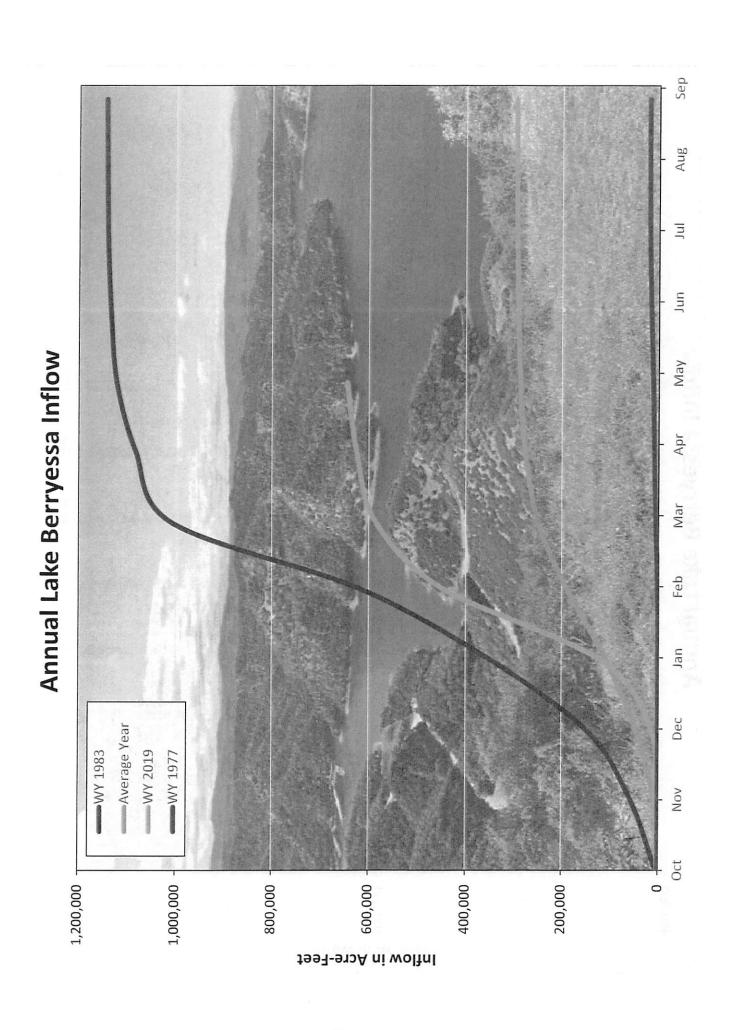


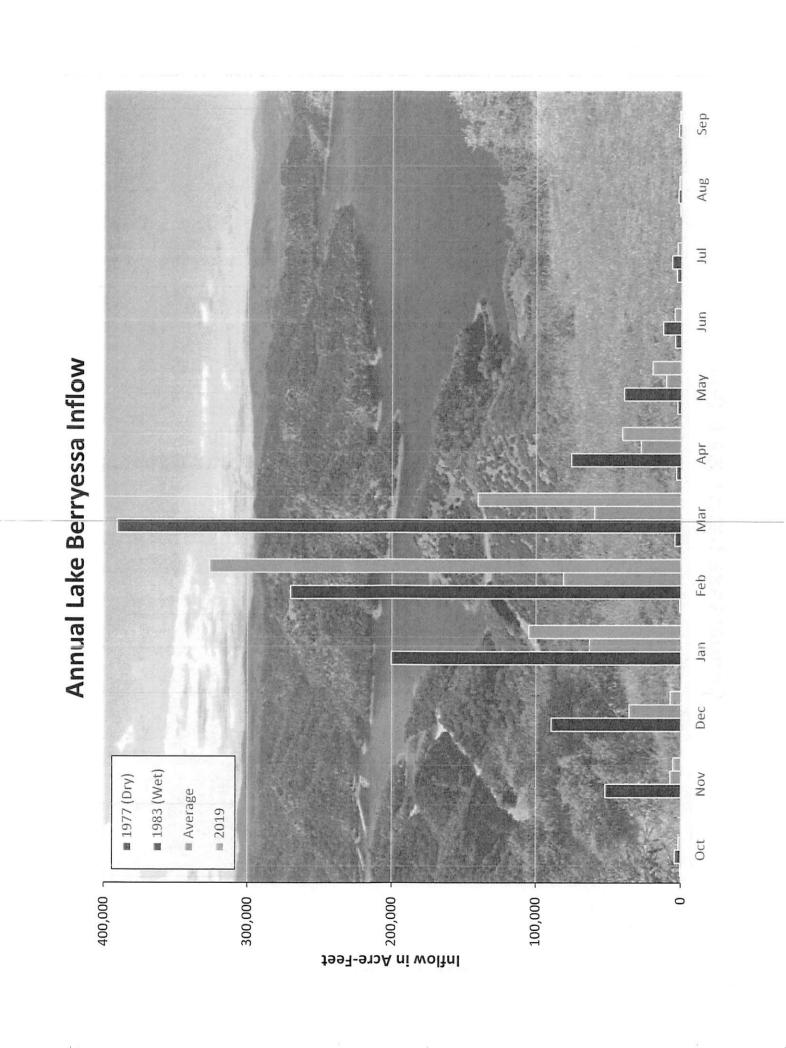
North Delta Arc Study 2018 Annual Report

Dr. John Durand and his team of researchers at UC Davis recently submitted their "North Delta Arc Study 2018 Annual Report: Cache and Lindsey Slough Water Quality, Productivity and Fisheries" report. The study, which was initiated in 2012, is currently funded by the Water Agency. The Water Agency's involvement in the study began in 2017, when among other things, the study area was expanded to include additional sampling in Barker and upper Lindsey Slough, as well as Upper Cache Slough. As hoped, the study is producing valuable information that will be used to guide future restoration activities at the Water Agency's Petersen Ranch, and has also identified potential habitat mitigation opportunities that the Ulatis Flood Control Project, which drains to Upper Cache Slough, could provide on behalf of the Solano Project and/or in concert with the Solano Project Habitat Conservation Plan.

Solano Project Habitat Conservation Plan

Preparation of the Solano Project Habitat Conservation Plan is required pursuant to the 1999 Solano Project water supply contract between the Water Agency and Reclamation. It has been a long journey to say the least – one that is finally coming to the end, at least with respect to plan preparation and adoption by the regulatory agencies. A lengthy presentation to the Board is tentatively scheduled for this coming August.

Sustainable Solano is connecting a neighborhood through gardening

A Vallejo neighborhood was a hub of activity Saturday as participants worked to create Sustainable Solano's first Resilient Neighborhood on a stretch of Louisiana Street

The group, which began as a Benicia community garden, has grown to create sustainable gardens in front and back yards around the County, and this is its first time expanding to include four neighboring houses.

Program Manager Kassie Munro of Napa said this project is the group's largest in scale and scope, but members hope the concept catches on and such sustainable, edibles and shade-producing gardens start springing up all over Solano County.

"We want to see neighborhoods that take better care of their environment and each other," she said. "We're focusing on creating life-supporting eco-system services - producing food, creating shade and cycling water. We capture roof water and use it by channeling it through swales, to where we want it to go."

Program spokeswoman Allison Angel, said the plan is to transform this central Vallejo street "into an environmentally and socially resilient community hub. Using landscaping elements of our Sustainable Backyard program as a foundation, this new program will build in additional resiliency elements focused on temperature regulation and strengthening community networks."

The design will treat the homes as part of the same ecosystem, linking them together through shared services and planned diversity, like providing shade in communal areas and producing a varied supply of food, she said.

"Over time, we plan to work with this established team to bring additional neighbors and community organizations into the hub as part of a larger movement to transform our cities into more regenerative, equitable and resilient places to live," Angel said.

Plants going in, in the back and/or front yards of the four homes selected include native edible perennials, pollinators and various types of fruit trees.

"It's about stacking functions," Munro said. "Like, an orange tree – it produces shade, provides food, captures carbon and helps cycle water. We're trying to create a shift change, back to the way nature designed it."

Thirty-three-year Benicia resident Marilyn Bordet is chair of Sustainable Solano. She said the backyard program worked so well, "We decided to expand it. We're all about resilient neighborhoods."

The group applied for and was awarded a \$100,000 PG&E Foundation grant to help fund the effort, she said.

"It's like environmental justice," Bordet said. "Like the victory gardens in world War II. We're trying to get back to some of the things Americans have always done. We're trying to encourage small sale farming in Solano County."

At least a dozen volunteers, including the neighbors whose yards are being transformed, and some whose yards aren't yet, pitched in to held Saturday.

"I'm interested in doing this for my yard; for my neighborhood," said Maria Munoz, who stopped by Saturday, but lives in another part of town. "I attended some of the workshops. I believe in their principals – in using native plants, pollinators and good use of water."

Joanna Palmer said her house is among those selected for inclusion, and she couldn't be more excited.

"We've been in California about a year and a half, partly to be in a climate that's enjoyable to be outside in, where you can grow a garden," she said. "So Carla, our neighbor, met someone from sustainable Solano at an event and was told about this program, and told us about it and the minute we saw that, we knew we wanted to be involved."

Palmer said she and her family like the principles – more sustainability, efficient use of water, more edibles.

"We're getting a loquat tree and a couple of pineapple guavas," she said.

At least a couple of electeds stopped by to check on the project's progress on Saturday, the women said.

"The mayor (Bob Sampayan) was here, and Supervisor (Monica) Brown," she said. "It's pretty neat."

They hope the idea will spread.

"Permaculture. It's designing with nature, and it's already catching on," she said. "

Projects like Saturday's are a combination of community work day and handson educational workshop," Munro said. "It's creating people who can then teach it to others. It's low-tech, accessible. Anyone can do it."

Work on the Resilient Neighborhood Pilot Project is expected to go on until June.

Dominic Sanchez said his wife got their family involved in the project.

"They're going to do our front yard," he said, as he manhandled a mountain of mulch in a wheelbarrow. "We'll have a couple of trees... a Santa Rosa plum, and some kind of citrus. I love the idea that they're putting up fruit that people can walk by and grab a piece."

Solano Water Advisory Commission Meeting Minutes April 24, 2019

The meeting was called to order at 12:34 PM.

1. Approval of Minutes

The minutes of the March 27, 2019 meeting were unanimously approved.

2. SCWA General Manager's Report

- a. Water Supply-Demand Analysis Working Group: No update.
- b. Ulatis Channels Working Group: No update.
- c. SCWA Board Items: The May SCWA Board of Directors meeting is cancelled.
- d. North Bay Aqueduct:
 - i. Water Exchanges: The Water Policy Committee met to discuss exchanges. Thomas Pate (SCWA) gave a detailed presentation on the SWP water types, Roland Sanford will distribute the presentation to the group. Roland discussed with the Commission a potential deal of Browns Valley water being passed through SCWA to Dudley Ridge Water District. The total amount is 3,100-AF, with Dudley Ridge paying \$25/AF to SCWA in administration fees. Fairfield, Benicia, Vacaville and Vallejo all expressed interest in the "swap" of Table A for Browns Valley water this year. Roland will send a draft agreement to the interested members. Chris Lee stated that there is not much CEQA risk since the total amount of water is very small. Members expressed hesitancy to take back exchange water from last year's Santa Clara Valley Water District and Dudley Ridge Water District transfer, as this year's water supply portfolio is very good.
 - ii. NBA Treatment Analysis: RPF has not yet been released.

a. SGMA Update: Chris Lee talked about the three public forums in Dixon, Rio Vista, and Vacaville. The meetings were mostly well attended and successfully answered many stakeholders' questions. The next big step will be putting together an overall Solano Subbasin Water Budget. This will entail of a lot of data collection and analysis, will take 6-12 months for rough numbers, and 12-18 months for additional refinement.

4. Solano County Report

Misty Kaltreider talked about the upcoming Solano Agricultural Tour, which will focus on locations involved in land use issues, soil characteristics, and agriculture water supply. The agenda/itinerary is on the County's website. Roland Sanford talked about the Petersen Estates parcels being sold to the Flannery Group, who are also buying up a significant amount of land in Solano County at well above market appraised value.

5. PSC/NBA Maintenance

Jeff Barich informed the group that DWR will be fixing a leaking transformer at the Cordelia Pumping Plant, which will likely take the NBA (downstream of the Plant) offline for up to two weeks while this is being fixed. The group will be updated on the status once DWR has more information.

6. Legislative/Initiative/Court Decision Issues (Not Discussed Above)
Roland Sanford mentioned SB 45 Water Bond, and that he will be monitoring it closely in the near future, but likely won't be implemented until 2020 or 2021. Roland Sanford talked about the Friends of Putah Creek lawsuit, and that SCWA's motion for dismissal was denied. Curtis Paxton mentioned that Vacaville's lawsuit for Chromium-6 is slowly moving

forward, and will likely be another 3-4 months before anything changes.

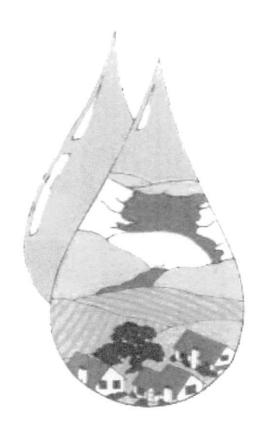

General Manager's Budget Message

FY 2019/20 Proposed Budget June 2019

Overview

The Water Agency's financial position remains strong. Due to significantly lower than anticipated expenditures coupled with higher than anticipated revenues, the Water Agency's cumulative fund balance is projected to be at least \$47,759,320 at the close of FY 2018/19, a net increase of approximately \$3,391,313 from the prior fiscal year (see Figure 1 and Figure 2). Major expenditures that were planned but did not occur in FY 2018/19 include the purchase of Habitat Conservation Plan (HCP) easements (\$3,000,000) and project delays associated with the Dixon Watershed Implementation Program (\$500,000).

The Water Agency's budget is comprised of four funds; the Administration-Solano Project — Watermaster (ASW) Fund, State Water Project Fund, Ulatis Flood Control Fund, and Green Valley Flood Control Fund. The latter three are "restricted" funds — the respective revenue streams cannot be redirected to other funds — while the former, the ASW Fund, in addition to supporting Solano Project operations and administration, also serves as the Water Agency's general fund — revenues can be used for any purpose. A summary of the four funds is as follows:

Long Term Outlook

The Water Agency's responsibilities have expanded over the years, early on with the adoption of the Putah Creek Accord and commitment to prepare and implement the Solano Project Habitat Conservation Plan, regional coordination of water conservation activities in Solano County, technical support for the North Bay Aqueduct Alternate Intake Project, and more recently with the adoption of the Flood Management Policy, and participation in the development of the Solano Subbasin Groundwater Sustainability Agency and Groundwater Management Plan. To some degree the level of effort associated with these newer responsibilities has or will be peaking at different times – different years – and with somewhat different fiscal impacts to the four respective Funds.

ASW Fund

With the notable exception of the NBA Alternate Intake Project and related technical studies, most of the aforementioned responsibilities have or will be financially supported by the ASW Fund. In the short term – next two to three years – the ASW Fund balance will be drawn down to accommodate technical studies in support of Voluntary Agreement development and participation in the ongoing Bay Delta Plan Update proceedings, as well as the "jump start" of the Solano Project Habitat Conservation Plan. Shortly thereafter, with the anticipated implementation of the Solano Sub-basin Groundwater Sustainability Plan, there will likely be significant and at least short term groundwater management expenditures – all this plus the ongoing operations and maintenance costs associated with the Solano Project, implementation of the Flood Management Policy, and water conservation programs.

While property taxes, the primary source of revenue for the ASW Fund, are expected to increase over the long term, staff believes it would be prudent to explore and wherever possible develop additional revenue streams to support the ASW Fund. To that end, the proposed FY 2019-2020 budget includes \$100,000 for a Solar feasibility study, as well as \$100,000 to develop a Hazard Mitigation Plan that would make the Water Agency available for FEMA hazard mitigation grant funding – a possible revenue source for certain rehabilitation and betterment projects. Other potential revenue sources are under consideration. In summary, additional revenue streams are needed to expand the "financial pie", otherwise in future years the available "slices" attributable to the various functions the ASW Fund supports will most likely need to be smaller.

State Water Project Fund

Nearly half of the Water Agency's cumulative fund balance is attributable to the State Water Project Fund. While seemingly robust, at least in the short term, significant expenditures are anticipated in the next three to seven years, as the planning, environmental review, and design of what is currently anticipated to be a \$600 million construction project resume in earnest. Currently the Water Agency is funding several technical studies to support formulation of a multi-benefit North Bay Aqueduct Alternate Intake Project (NBA AIP) that will hopefully attract significant financial contributions from the Federal and State governments. The planning, environmental review, and design of the NBA AIP are expected to cost on the order of \$10 to \$15 million.

Also of note are the rising operations and maintenance costs of the existing NBA facilities, particularly with the respect to "Delta Water Charges" and the associated Federally mandated habitat mitigation requirements of the State Water Project in general, as well as the rising cost of electricity. Currently, there is sufficient revenue to offset operations and maintenance expenditures. However, there is considerable uncertainty with respect to future operations and maintenance costs, particularly in regards to electricity.

Ulatis Flood Control Fund

The Ulatis Flood Control Fund has benefited from increased property values associated with the conversion of agricultural lands to residential housing at and near Vacaville. Then again, urbanization has created new challenges and expenses. Significant capital expenditures, most notably a series of grade control weirs, are anticipated in the next five years, assuming the Solano Project Habitat Conservation Plan is formally approved by the Federal and State resource agencies in the next 12 to 18 months. Once approved, the Solano Project Habitat Conservation Plan will provide streamlined permitting that will facilitate the environmental review and compliance matters associated with these capital projects. Adoption of the Solano Project Habitat Conservation Plan will also obligate the Ulatis Flood Control Project to mitigate for the loss of Giant Garter Snake and other special status species habitat — estimated to cost approximately \$1 million.

On the whole, the Ulatis Flood Control Fund is in good shape for the foreseeable future – no discernible negative expenditure or revenue trends, sufficient reserves to accomplish anticipated capital improvement projects, with funds remaining to explore new opportunities.

Green Valley Flood Control Fund

When constructed, the predominant land uses in and around the Green Valley Flood Control Project were agricultural and rural residential. Property tax revenues were modest and out of necessity, operations and maintenance expenditures were backstopped via loans from the ASW Fund. Land uses have shifted over time and are now predominantly residential and commercial, which has enhanced property tax revenues and made it possible to reimburse the ASW Fund. However, urbanization, in addition to sea level rise are creating significant operations and maintenance challenges and the financial position of the Green Valley Flood Control Fund, while certainly better in recent years, will continue to be marginally adequate for the foreseeable future.

Proposed FY 2019/20Budget

The FY 2018/19 budget was designed with the expectation that the Water Agency's reserves would be drawn down by approximately \$6,500,000 to fund certain one-time and short term expenditures. Due to project delays, most notably with regard to the Solano Project Habitat Conservation Plan, and higher than anticipated revenues, nearly the opposite has occurred – the Water Agency's cumulative fund balance is projected to increase by at least \$3,391,313 at the close of FY 2018/19 (note: the FY 2018/19 year end projections presented in the attached charts and tables are conservative in that projected expenses have been "high balled", resulting in a conservatively low estimate of the projected FY 2018/19 cumulative fund balance).

As discussed below, the proposed FY 2019/20 budget is crafted in the same manner as the FY 2018/19 budget and again, with the expectation that reserves will be drawn down by approximately \$8,000,000 to fund certain one-time and short term expenditures, most of which are carryovers from

FY 2018/19. As proposed, total FY 2019/20 expenditures (\$47,368,809) exceed total anticipated FY 2018/2019 revenues (\$38,992,979), with the difference (\$8,375,830), to be withdrawn from reserves.

The proposed FY 2019/20 budget has been constructed around the goals and objectives set forth in the SCWA 2016-2025 Strategic Plan, but also reflects emerging challenges and opportunities, most notably increased expenditures directed toward groundwater management and compliance with California's Sustainable Groundwater Management Act, technical studies related to the State Water Resources Control Board's ongoing and the contentious update of the 2006 Bay Delta Plan, an expanded role in habitat restoration, as well as an expanded role with the Lake Berryessa invasive mussel control program. A summary of projected FY 2019/20 expenses and revenues, along with long-term expense and revenue trends, is presented in the following charts and tables. Key budget items to be largely funded from reserves are as follows:

Solano Habitat Conservation Plan (HCP)

The Draft Solano Project Habitat Conservation Plan is in the hands of the United States Fish and Wildlife Service (Service), awaiting the Service's final review and approval. It was anticipated that the plan would be approved by the Service in FY 2018/19 and therefore, significant expenditures, including \$3,000,000 for conservation easements, were programed into the FY 2018/19 budget. These expenditures did not occur and are now included in the proposed FY 2019/20 budget.

SCWA Office Expansion

In 2018 the Board authorized staff to explore opportunities to expand the existing SCWA office through the purchase of unoccupied space immediately adjacent to the existing office. The research has taken longer than anticipated due to complexities regarding ownership of the building and existing cost sharing arrangements between the Water Agency and the Solano Irrigation District. That research is nearly complete and pending final Board approval, staff is prepared to move forward with the office expansion. The proposed FY 2019/20 budget includes \$2,500,000 for the SCWA office expansion project.

Flood Management

The proposed FY 2019/20 budget includes \$300,000 for the Hydrology Manual and Master Drainage Plan updates (Task 1 of the adopted 2018 Flood Management Policy), and \$500,000 for implementation of the Dixon Watershed Management Plan.

Facilities Risk Analyses

Staff is proposing to hire an outside firm to inspect the Solano Project, Ulatis Flood Control Project, and Green Valley Flood Control Project facilities for potential safety hazards, and where appropriate, recommend corrective action. A total of \$300,000 has been budgeted for these inspections and implementation of associated corrective actions.

State Water Resources Control Board Update of 2006 Bay-Delta Plan

The State Water Resources Control Board (SWRCB) has begun what will be a lengthy and contentious update of the 2006 Bay-Delta Plan. In short, the SWRCB is seeking to increase stream flows into and through the Bay-Delta to stabilize if not enhance the ecology of the Bay-Delta. The additional water would come from existing water right holders, most notably, reservoirs located on the tributaries of the Sacramento and San Joaquin rivers — one of which is Lake Berryessa. The proposed FY 2019/20 budget includes \$450,000 for technical studies to investigate options for minimizing the potential water supply impacts of the SWRCB's Bay Delta Plan Update to the Lake Berryessa water supply.

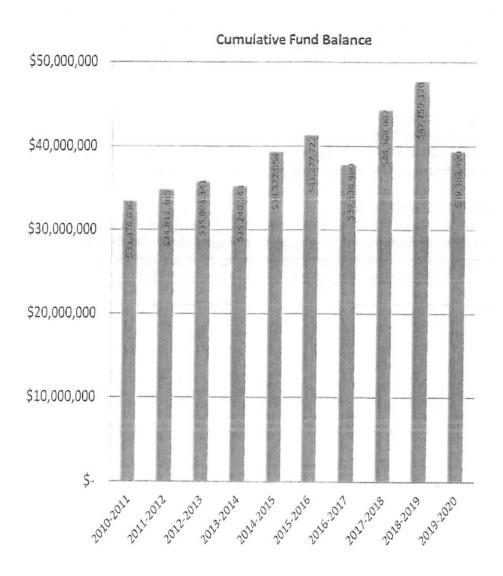
Water Management Planning

The proposed FY 2019/20 budget includes \$200,000 for a countywide current-future water needs analysis and preparation of the SCWA Water Management Plan, as well as \$700,000 for technical studies in support of water management planning in the Yolo Bypass/Cache Slough region.

CalPERS Unfounded Pension Liability

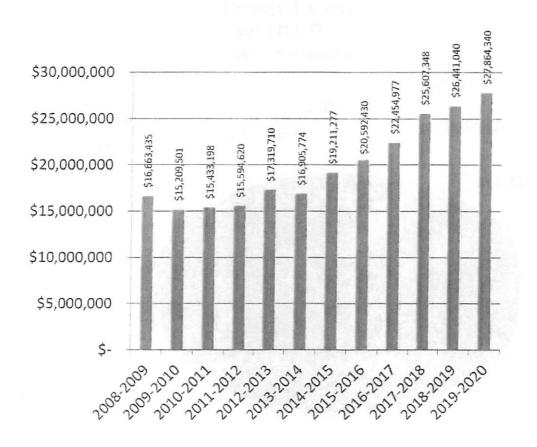
In FY 2018/19 the Water Agency paid off the accumulated OPEB (Other Post Retirement Employee Benefits) liability and began to pay off the accumulated unfunded CalPERS pension liability. Staff is proposing to pay off the remaining accumulated unfunded CalPERS pension liability in FY 2019/20 - \$750,000 has been programed into the proposed FY 2019/20 budget for this item.

Summary of Projected Revenues FY 2019-2020 Total Revenues - \$38,992,979

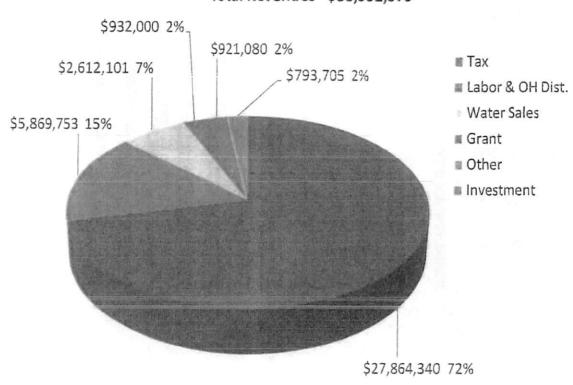

Summary of Projected Expenditures FY 2019-2020 Total Expenditures - \$47,368,809

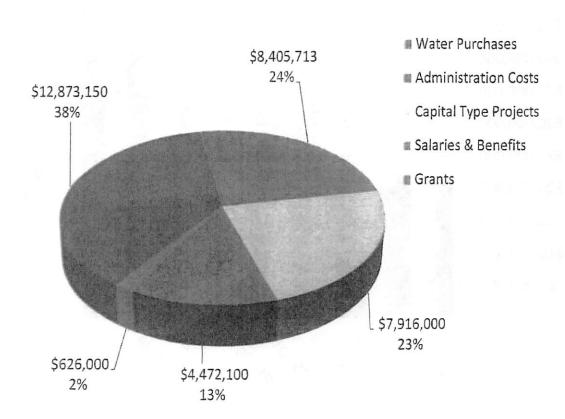
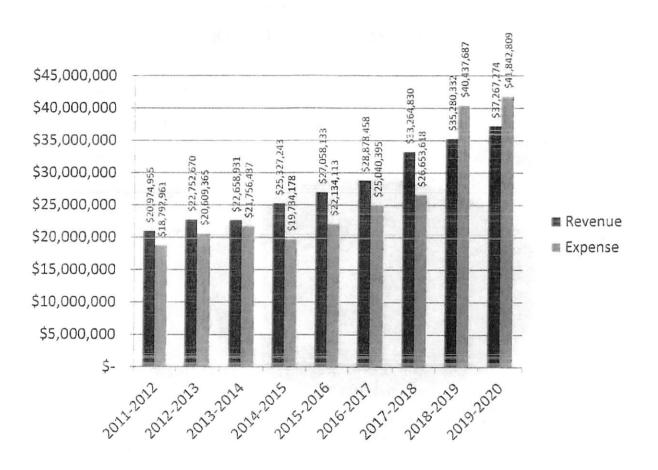

FY 2019/20 PROPOSED BUDGET

FUND PURPOSE

The Administration-Solano Project-Watermaster (ASW) fund is comprised of three sub-funds; Administration, Solano Project, and Watermaster. Unlike the Water Agency's State Water Project, Ulatis and Green Valley funds, which for accounting purposes are defined as "restricted" funds, the ASW is a "general fund" and therefore the monies within the ASW fund can be used for any purpose – flood control, groundwater monitoring, water conservation, etc.

FUNCTION AND RESPONSIBILITES

Administration – The Administration sub-fund provides human resource and other administrative support for SCWA staff, as well as funding for SCWA's general flood control, groundwater monitoring and Solano Subbasin Groundwater Sustainability Agency administrative support, integrated regional water management planning, and water conservation activities.

<u>Solano Project</u> - The Solano Project sub-fund supports the Solano Project water supply, including operation and maintenance of the Solano Project facilities (Monticello Dam, Putah Diversion Dam, and Putah South Canal), compliance with the Putah Creek Accord and a variety of technical studies and administrative functions in support of the Lower Putah Creek Coordinating Committee (LPCCC), and implementation of the Solano Habitat Conservation Plan (HCP).

<u>Watermaster</u> – The Watermaster sub-fund is used to implement the Condition 12 water rights settlement in the Lake Berryessa watershed.

FUND DETAIL COMMENTS

Revenues

<u>Property Taxes</u> - FY 19/20 tax revenues are projected to increase 8% from the prior fiscal year, reflecting the ongoing trend of increasing property values in Solano County.

Grant Revenue – Water Conservation grant to end at the close of FY 2018-2019.

Investment Income - Based on reserve fund balance and prevailing interest rates.

Other Revenue Sources – FY 19/19 revenue less than anticipated due to project delays associated with LPCCC projects (LPCCC billable services).

Expenditures

<u>Salaries & Benefits</u> – SCWA to pay off accumulated unfunded Pension Liability (\$750,000 budgeted for FY 2019-2020) and remain current with annual OPEB costs.

<u>Services and Supplies</u>— In FY 2018-2019 SCWA made a one-time \$350,000 contribution to the Solano Sub-basin Groundwater Sustainability Agency to augment grant funds obtained from DWR for preparation of Solano Sub-basin Groundwater Sustainability Plan. FY 19/20 expenditures projected to increase largely due to increased public education, computer equipment, and human resources support service expenses.

Operations and Maintenance - FY 18/19 expenditures less than anticipated, particularly with regard to PSC O&M.

LPCCC Operations- Increased expenses due to less grant funding.

<u>Watershed Management</u> - A new funding category intended to differentiate traditional "hard" infrastructure (Monticello and Putah Diversion dams, Putah South Canal) operations & maintenance expenditures from biological/physical science investigations such as the ongoing Lower Putah Creek Chinook Salmon Study and the ongoing Lake Berryessa Invasive mussel control program. Includes expenditures related to the Lower Putah Creek Coordinating Committee - but not mandated by the Putah Creek Accord - and technical studies pertaining to the State Water Resources Control Board's Bay Delta Plan Update.

<u>Rehab & Betterment</u> - Increased funding for ongoing multi-year rehab & betterment projects, such as Putah South Canal drainage repair and canal panel replacement, and funding for "one-time" projects such as the replacement of the Putah Diversion Dam radial gate seals. Electrical upgrades, and PSC Seismic Assessment.

Grant Expenditures - The River Park and Coastal Conservancy projects will be ending in FY 19/20.

<u>Water Conservation</u> – FY 18/19 Expenditures less than anticipated due to reduced participation in water conservation rebate programs.

<u>Flood Control</u> – FY 18/19 expenditures less than anticipated due to project delays associated with Dixon Watershed Management Plan implementation, FY 19/20 expenditures projected to Increase to accommodate updates of Hydrology Manual and a Flood Master Plan, and increased participation in Water Agency grant funded programs.

HCP - FY 18/19 expenditures less than anticipated due to project delays (did not purchase conservation easements).

<u>Consultants</u> – Funding has been increased in anticipation of several new technical studies related to the operation of the Solano Project and the State Water Resources Control Board's ongoing update of the 2016 Bay-Delta Plan, groundwater investigations, and IT services.

<u>Fixed Assets</u> – Funding has been included for a trailer compressor and a 2 row transplanter for use on Putah Creek; an additional Mobile Wash Station for the Mussel program; three vehicles to be used by SID for Putah South Canal operations and maintenance, in lieu of SCWA paying SID for use of their vehicles; additional streamflow and water quality monitoring equipment; and the Fund's share of SCWA office expansion.

FUND PURPOSE

Repayment of capital costs, ongoing operations and maintenance of the North Bay Aqueduct.

FUNCTION AND RESPONSIBILITES

SCWA is responsible for purchasing water from the State Water Project for resale to cities in Solano County. Water is delivered via the North Bay Aqueduct (NBA), which originates in Barker Slough and terminates in Napa County (Napa County has a similar State Water Project water supply contract). The NBA is owned, operated, and maintained by the California Department of Water Resources (DWR). SCWA administers the State Water Project water supply contract, which among other things, obligates SCWA to reimburse DWR for Solano's share of the NBA operation, maintenance, and capital costs. The majority of the funds used to reimburse DWR are obtained via the "NBA Zone of Benefit Tax" – a property tax assessment. In addition to administering the water supply contract, SCWA performs various technical studies related to NBA operations, monitors water quality in Barker Slough, and provides technical assistance to DWR in support of the NBA Alternate Intake Project.

FUND DETAIL COMMENTS

Revenues

<u>Property Taxes</u> – FY 19/20 proposed property tax revenues are projected to increase by 10% from the prior fiscal year, reflecting ongoing trend of increasing property values in Solano County.

<u>Grant Revenues</u> – Increase due to reimbursement of Prop. 84 NBA AIP Grant.

<u>Investment Income</u> –Based on reserve fund balance and prevailing interest rates.

<u>Other Revenue Sources</u> – Includes refunds from DWR for prior year advance funding of SWP expenses and grant reimbursement from DWR associated with the NBA Alternate Intake Project.

Expenditures

<u>Operations and Maintenance</u> – Lower than anticipated FY 18/19 expenditures due to favorable water quality conditions.

Water Purchases - 2% increase based on Department of Water Resources' projected Statement of Charges.

Water Conservation - Budget reduced due to Grant funded activities projected to end during 2019/20.

<u>Consultants</u> – Lower than anticipated FY 18/19 expenditures due to suspension of Draft NBA AIP EIR and project delays associated with YBCS Management Planning Project. UCD Cache Slough Fisheries and Water Quality Study and other studies in support of multi-benefit NBA AIP to continue in FY 19/20.

Fixed Assets - Installation of water quality monitoring station and SWP Fund's share of SCWA office expansion.

FUNCTION AND RESPONSIBILITES

The Ulatis Flood Control Project (Project) was constructed by the Soil Conservation Service (now known as the Natural Resources Conservation Service) and is maintained by SCWA pursuant to a contract with the Natural Resources Conservation Service. The Project consists of over 45 miles of flood control channels and is largely located within and provides flood protection to agricultural lands downstream of Vacaville. SCWA subcontracts with the Solano County Transportation Department for routine maintenance duties while most engineering and administrative functions are performed by SCWA staff.

FUND DETAIL COMMENTS

Revenues

<u>Property Taxes</u> - FY 19/20 proposed tax revenues are projected to increase 9% from the prior fiscal year, reflecting ongoing trend of increasing property values in Solano County.

<u>Investment Income</u> –Based on reserve fund balance and prevailing interest rates.

Expenditures

<u>Operations and Maintenance</u> – Lower than anticipated FY 18/19 expenditures due to fewer and generally less damaging storm events.

<u>Fixed Assets</u> – Includes funding for a Boom Mower and Wheeled Excavator that were ordered in FY 18/19 and will be delivered in October 2019, and the Fund's share of SCWA office expansion.

FUND PURPOSE

Operation and maintenance of Green Valley Flood Control Project.

FUNCTION AND RESPONSIBILITES

The Green Valley Flood Control Project (Project) was constructed by the United States Army Corps of Engineers (USACOE) and is maintained by SCWA pursuant to an agreement with the USACOE. The Project consists of approximately 3 miles of flood control channels and is largely located in and downstream of Cordelia. SCWA subcontracts with the Solano Transportation Department for routine maintenance duties while most engineering and administrative functions are performed by SCWA staff.

FUND DETAIL COMMENTS

Revenues

<u>Property Taxes</u> - FY 19/20 proposed tax revenues are projected to increase 9% over prior fiscal year, reflecting ongoing trend of increasing property values in Solano County.

Investment Income - Based on reserve fund balance and prevailing interest rates.

Expenditures

<u>Operations and Maintenance</u> – Operations and maintenance expenses are projected to increase due to inclusion of one-time "Green Valley Facilities Risk Assessment Project", initiation of "Bank Stabilization Project", and an expected increase in related labor costs.

Fixed Assets - No significant fixed asset purchases anticipated, other than Fund's share of SCWA office expansion.

Solano County Water Agency

Reserves Summary

At the close of FY 2018-2019 the Water Agency's total fiscal reserves are projected to be within five percent of the recommended total fiscal reserves for FY 2019-2020. However, as discussed below, the current and projected reserves for FY 2019-2020, while meeting the Water Agency's operating reserves criteria (one-half of annual estimated operating expenditures), are for the most part not sufficient to address long-term capital improvements. A "reserves fund status" for each of the Water Agency's funds; Admin-Solano-Watermaster, State Water Project, Ulatis Flood Control, and Green Valley Flood Control), is presented below.

Admin-Solano Project-Watermaster (ASW) Fund

The ASW Fund's operating expenditures have been increasing over time as the fund supports new and expanding programs, most notably the SGMA groundwater related activities and implementation of the recently adopted Flood Management Policy. As indicated in the following tables, there are currently sufficient funds to meet the Water Agency's operating reserves criteria, but not without foregoing at least some of the anticipated capital improvement projects over the next five years.

State Water Project Fund

As indicated in the following tables, the State Water Project Fund's reserves are currently sufficient to meet the Water Agency's operating reserves criteria and address short-term (within the next five years) capital improvements. However, significant North Bay Aqueduct capital expenditures are anticipated in the coming years, as the proposed North Bay Aqueduct Alternate Intake Project moves forward. Within the next ten years it is anticipated that the Water Agency will spend \$ 15,000,000 on the preliminary design and environmental permitting for the North Bay Aqueduct Alternate Intake Project. Project construction, which is at least 10 years away, is estimated to cost on the order of \$ 600,000,000. Project construction, operations and maintenance will ultimately be paid by the project beneficiaries. However, the preliminary project design and environmental permitting will be largely borne by the Water Agency. At the close of FY 2018-2019 the Water Agency's State Water Project Fund is projected to hold roughly \$ 8,700,000 in reserves for preliminary design and environmental permitting of the North Bay Aqueduct Alternate Intake Project — a little more than half of the projected \$ 15,000,000 need.

Ulatis Flood Control Fund

The Ulatis Flood Control Fund's reserves are currently sufficient to meet the Water Agency's operating reserves criteria and address anticipated short-term capital improvements. However, the existing reserves are not sufficient to address even one-half of the anticipated long-term capital improvement projects.

Green Valley Flood Control Fund

At the closes of FY 2019-2020 it is anticipated that the Green Valley Flood Control Funds will be barely adequate to satisfy the Water Agency's operating reserves criteria, with no funds available for additional short-term capital improvement projects.

Significant North Bay Aqueduct capital expenditures are anticipated in the coming years, as the proposed North Bay Aqueduct Alternate Intake Project moves forward. Within the next ten years it is anticipated that the Water Agency will spend \$ 15,000,000 on the preliminary design and environmental permitting for the North Bay Aqueduct Alternate Intake Project. Project construction, which is at least 10 years away, is estimated to cost on the order of \$ 600,000,000. Project construction, operations and maintenance will ultimately be paid by the project beneficiaries. However, the preliminary project design and environmental permitting will be largely borne by the Water Agency. At the close of FY 2018-2019 the Water Agency's State Water Project Fund is projected to hold roughly \$ 8,700,000 in reserves for preliminary design and environmental permitting of the North Bay Aqueduct Alternate Intake Project – a little more than half of the projected \$ 15,000,000 need.

RESOLUTION 85-183

RESOLUTION ESTABLISHING A ZONE OF BENEFIT WITHIN THE SOLANO COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT AND ESTABLISHING A PROPERTY TAX RATE FOR THE ZONE OF NOT TO EXCEED \$.02 PER \$100 ASSESSED VALUATION

WHEREAS, the North Bay Aqueduct is a part of the California State Water Project approved by the voters of California in 1960 and is now under construction and will provide for the delivery of a significant quantity of water for utilization by the citizens of Solano County; and

WHEREAS, the Solano County Flood Control and Water Conservation District (hereinafter "District") has contracted with the State of California acting by and through its Department of Water Resources on behalf of certain member unit cities within Solano County for the provision of water from the North Bay Aqueduct, which cities include Benicia, Fairfield, Suisun City, Vacaville, and Vallejo (hereinafter "member units"); and

WHEREAS, a method of financing the North Bay Aqueduct, other than that available through District's present share of property taxes and other usual revenues, is necessary to meet present contracts; and

WHEREAS, the North Bay Aqueduct Financing Committee has made recommendations to this Board relative to the means of financing water which will be received from the North Bay Aqueduct; and

WHEREAS, the approach recommended by the North Bay Aqueduct Financing Committee provided solutions to the "make whole claims" of the Napa County Flood Control and Water

Conservation District relative to certain member units of the District, and provided an acceptable method of financing water which could be delivered within the District by the North Bay Aqueduct, but would have imposed a tax on areas of the District neither served by water from the North Bay Aqueduct or the existing Solano Water Project which now serves portions of Solano County; and

WHEREAS, this District has the authority to establish a budget and tax rate in excess of the one percent (1%) property tax limitation in order to finance receipt of water from the North Bay Aqueduct which is a part of the State Water Project approved by the voters of California in 1960; and

WHEREAS, this District further has the authority to establish a tax rate either Districtwide, or within a zone of benefit, under the provisions of the Solano County Flood Control and Water Conservation Act (Chapter 1656 of the Statutes of 1951, as amended); and

WHEREAS, this District has authority to create a zone or zones of benefit because of varying benefits to the property within the District for the purpose of paying certain costs, expenses, and indebtedness of the District and its member units; and

WHEREAS, the North Bay Aqueduct water entitlements, as well as an existing partial subsidy of water from the existing Solano Water Project from District's normal county-wide property tax revenues, establish varying benefits to property within the District; and

WHEREAS, a map, consisting of three sheets, has been prepared showing the boundaries of the territory to be included in the zone of benefit and a copy of said map has been marked as Exhibit "A" and attached hereto; and

WHEREAS, said Exhibit "A" includes three sheets, one sheet showing all of the area of said proposed zone of benefit except the Rio Vista Area and the Dixon Area (outside the Solano Irrigation District), a second sheet showing the Rio Vista Area, and a third sheet showing the Dixon Area (outside the Solano Irrigation District); and

WHEREAS, the Cities of Benicia, Fairfield, Suisun City, and Vacaville will benefit from the North Bay Aqueduct since said cities have contracted to receive North Bay Aqueduct water; and

WHEREAS, the Cities of Rio Vista and Dixon are now being offered benefits from the North Bay Aqueduct through contracts granting them the option to receive North Bay Aqueduct water provided said contracts are executed on or before December 15, 1985 and that they exercise the option in said contracts on or before January 1, 2020; and

WHEREAS, if an option contract for the possible future delivery of North Bay Aqueduct water to the City of Rio Vista is not executed on or before December 15, 1985, in the judgment of this Board it is not appropriate to levy a tax within the portion of the proposed zone of benefit within the Rio Vista Area as shown on sheet two of Exhibit "A"; and

WHEREAS, if an option contract for the possible future delivery of North Bay Aqueduct water to the City of

Dixon is not executed on or before December 15, 1985, in the judgment of this Board it is not appropriate to levy a tax within the portion of the proposed zone of benefit within the Dixon Area (outside the Solano Irrigation District) as shown on sheet three of Exhibit "A"; and

WHEREAS, the City of Vallejo will receive benefit from the North Bay Aqueduct from both a water entitlement and from utilization of the North Bay Aqueduct for transmission of water from other entitlements that will, in turn, allow Vallejo the benefit of not having to bear the expense of replacing their own transmission lines; and

WHEREAS, the maximum rate to be charged to member units for North Bay Aqueduct water is to be \$20.50 per acre foot, or that amount charged for municipal and industrial water from the existing Solano Water Project, whichever is higher; and

WHEREAS, the Solano Irrigation District and Main Prairie Water District benefit from the North Bay Aqueduct since the North Bay Aqueduct will ease pressures to convert Solano Project Water now utilized by those Districts from agricultural uses; and

WHEREAS, since Solano Project Water has been paid in part by a countywide tax of the District, it is appropriate that such areas also participate in the tax to pay for the North Bay Aqueduct; and

WHEREAS, the spheres of influence of each of the above-mentioned cities and districts could receive benefit from the North Bay Aqueduct because such areas include the probable ultimate physical boundaries and water service areas of such cities and districts; and

WHEREAS, some areas of this District are underlaid by a groundwater basin recharged by the Solano Water Project and other areas, such as the Suisun Marsh, are benefited by the passage of water through said areas and thereby benefit from the Solano Water Project and the North Bay Aqueduct; and

WHEREAS, on February 5, 1985 the Solano County
Board of Supervisors, acting ex officio as the Board of
Directors of District, adopted Resolution 85-24, entitled
"Resolution of Intention of the Solano County Board of
Supervisors to Establish a Zone of Benefit Tax for Financing
the North Bay Aqueduct", expressing its intent therein to
create a zone of benefit and to establish a tax rate therefor;
and

WHEREAS, on September 17, 1985 the Solano County Board of Supervisors, acting ex officio as the Board of Directors of District, adopted Resolution 85-164 entitled "Resolution Setting the Date, Time and Place for a Public Hearing on the Establishment of a Zone of Benefit Within the Solano County Flood Control and Water Conservation District and Establishing A Property Tax Rate for the Zone of Not to Exceed \$.02 per \$100 Assessed Valuation"; and

WHEREAS, notice of said hearing was duly published as required by law;

NOW, THEREFORE, BE IT RESOLVED, and it is hereby resolved by the Solano County Board of Supervisors, acting ex officio as the Board of Directors of the Solano County Flood Control and Water Conservation District, as follows:

- 1. The portion of the territory within the Solano County Flood Control and Water Conservation District described in Exhibit "A" is hereby established as Zone of Benefit No. 1 of the Solano County Flood Control and Water Conservation District.
- There shall be levied annually a property tax 2. within Zone of Benefit No. I in an amount necessary, but not to exceed two cents (\$.02) per one hundred dollars of assessed valuation for the purpose of paying the annual cost of the North Bay Aqueduct and the obligation for repayment of "up front" costs and advancements of the District under present contracts, in order to permit the cost per acre foot of water from the North Bay Aqueduct to be \$20.50 or the amount charged for municipal and industrial water from the Solano Water Project, whichever is higher. Said tax shall not be levied in the Rio Vista Area as shown on the second sheet of Exhibit "A" unless an option contract for the possible future delivery of North Bay Aqueduct water to the City of Rio Vista is executed on or before December 15, 1985. Said tax shall not be levied upon the Dixon Area (outside the Solano Irrigation District) as shown on the third sheet of Exhibit "A" unless an option contract for the possible future delivery of North Bay Aqueduct water to the City of Dixon is executed on or before December 15, 1985.

EMPLOYMENT COST INDEX - March 2019

(NOTE: This news release was reissued on April 30, 2019. Tables A, 1, 2, and 3 were corrected to show revised seasonally adjusted data for previous quarters.)

Compensation costs for civilian workers increased 0.7 percent, seasonally adjusted, for the 3-month period ending in March 2019, the U.S. Bureau of Labor Statistics reported today. Wages and salaries (which make up about 70 percent of compensation costs) increased 0.7 percent and benefit costs (which make up the remaining 30 percent of compensation) also increased 0.7 percent from December 2018. (See tables A, 1, 2, and 3.)

Civilian Workers

Compensation costs for civilian workers increased 2.8 percent for the 12-month period ending in March 2019 compared with a compensation costs increase of 2.7 percent in March 2018. Wages and salaries increased 2.9 percent for the 12- month period ending in March 2019 and increased 2.7 percent for the 12-month period ending in March 2018. Benefit costs increased 2.6 percent for the 12-month period ending in March 2019. In March 2018, the increase was also 2.6 percent. (See tables A, 4, 8, and 12.)

Private Industry Workers

Compensation costs for private industry workers increased 2.8 percent over the year, the same increase as in March 2018. Wages and salaries increased 3.0 percent for the 12-month period ending in March 2019 and increased 2.9 percent in March 2018. The cost of benefits rose 2.4 percent for the 12-month period ending in March 2019 and increased 2.5 percent in March 2018. (See tables A, 5, 9, and 12.)

Employer costs for health benefits increased 1.9 percent for the 12-month period ending in March 2019. (For further information, see chart 3 and www.bls.gov/web/eci/echealth.pdf.)

Among occupational groups, compensation cost increases for private industry workers for the 12-month period ending in March 2019 ranged from 2.3 percent for management, professional, and related occupations to 3.4 percent for service occupations. (See table 5.)

Among industry supersectors, compensation cost increases for private industry workers for the 12month period ending in March 2019 ranged from 2.2 percent for manufacturing to 4.8 percent for information. (See table 5.)

State and Local Government Workers

Compensation costs for state and local government workers increased 3.0 percent for the 12-month period ending in March 2019. In March 2018, the increase was 2.2 percent. Wages and salaries increased 2.5 percent for the 12-month period ending in March 2019, compared with 1.8 percent a year ago. Benefit costs increased 3.6 percent for the 12-month period ending in March 2019. The prior year increase was 3.0 percent. (See tables A, 7, 11, and 12.)

Funding for these consultants is included in the Fiscal Year 2019-2020 Budget.

BACKGROUND:

Staff is requesting authorization to execute the aforementioned 27 agreements totaling \$4,215,285.00 (by comparison, the Board authorized staff to sign 34 contracts totaling \$3,550,348.14 at the onset of FY 2018-2020). A brief synopsis of each contract is presented below. Copies of the above agreements are available on the SCWA web page (www.scwa2.com) or from SCWA staff.

- 1. AD Consultants will produce additional computer simulations of various Lake Berryessa operation scenarios in support of Bay-Delta Plan Update/Voluntary Settlement Agreement.
- 2. AG Innovations will provide facilitation, education, and outreach services for stakeholder meetings during development of the Solano Subbasin Groundwater Sustainability Plan.
- 3. Eyasco will continue to support and improve our extensive data collection network, they will continue to manage our website and provide database/reporting support. Additionally they will be assisting with our growing SCADA network and the development and expansion of our automated control system on the Putah South Canal.
- 4. GHD will provide administration for the Solano CII Water Conservation Program.
- 5. GHD will continue to provide administrative support for the IRWM Grant.
- 6. Jacobs Engineering Group will finalize the preparation of the Solano Habitat Conservation Plan.
- 7. Jeff Janik will continue to conduct phytoplankton analysis and enumeration of North Bay Aqueduct (NBA) and Solano Project samples.
- 8. LSA Associates will finalize the Solano Habitat Conservation Plan.
- 9. Luhdorff & Scalmanini will provide groundwater conditions reporting and groundwater management assistance including shallow monitoring wells near Putah Creek.
- Ovivo USA, LLC will provide 2 years of field support and parts as needed for the PDD automated raking system.
- 11. PCC Stewardship will continue to engage community volunteers at the native plant nursery and restoration plantings.
- 12. Putah Creek Council will provide public education, outreach and advocacy in Solano County and along Putah Creek with multiple projects.
- 13. Richard Heath & Associates will partner with PG&E to administer the Low income water savings program.
- 14. Shandam will continue to provide professional IT support for the Agency computer network including installation of completely new SCWA network.
- 15. Solano RCD will provide public education and outreach in Solano County with multiple programs over the next three fiscal years.
- 16. Solano RCD will work with landowners to protect the Barker Slough (i.e. NBA) Watershed, conduct an annual assessment, and other source control efforts for a period of 3 years.

- Solano RCD will administer the small grant program and provide public outreach and awareness for flood control issues.
- 18. Southwest Environmental will continue with the installation of water efficient products within Solano County.
- 19. Summers Engineering will provide engineering support for the Solano Project R&B Plan, the Solano Project and other engineering support as needed.
- Summers Engineering will provide engineering support for the PDD Bulkhead and Flood Gate Refurbishment project.
- 21. Sustainable Solano will continue current programs promoting use of rain and greywater.
- 22. Terraphase, will continue to monitor water quality in the Cached Slough from existing storm water discharges and target surface water sources.
- 23. UC Davis and Vic Claassen will provide support for bank stabilization pilot projects on Putah Creek, Pleasants Creek, Putah South Canal and Ulatis Flood project.
- 24. Waterfluence will administer the Regional Large Landscape Budget Program.
- 25. Wildlife Survey and Photo will continue to monitor the Solano Project for New Zealand Mud Snails and Quagga and Zebra Mussels in the Solano Project. In addition, photo and video media will be developed for Peterson Ranch and large SCWA projects.
- 26. Wilson Public Affairs will provide public and media outreach services.
- 27. Yolo Resource Conservation District will assist the Coordination Committee with administrative functions of the Westside IRWMP implementation.
