BOARD MEMBER REPORTS

Mayor Patterson reported that a lawsuit has been filed in opposition to the Metropolitan Water District of Southern California's (MET) recent purchase of five islands in the Sacramento-San

Joaquin Delta. She explained that the lawsuit seeks to invalidate the property purchase because MET has so far failed to comply with the California Environmental Quality Act (CEQA).

GENERAL MANAGER'S REPORT

There were no additions to the General Managers written report.

<u>PRESENTATION BY EKI – RESULTS OF SCWA SINGLE FAMILY RESIDENTIAL</u> <u>WATER USE AND CONSERVATION POTENTIAL PILOT STUDY</u>

Representatives from EKI, a private consulting firm, presented the results of their recent water conservation study, in which they evaluated the effectiveness of the Water Agency's various water conservation rebate programs. The study, which relied heavily on data provided by the City of Vallejo, concluded that significant water savings have been achieved through the various water conservation programs administered by the Water Agency, and that the potential exists for additional water savings. The Board thanked the EKI representatives for their informational presentation.

DISCUSSION AND POSSIBLE ACTION: WATER POLICY COMMITTEE RECOMMENDATIONS REGARDING FORMATION OF GROUNDWATER SUSTAINABILITY AGENCY (GSA) FOR SOLANO SUBBASIN

After extended discussion, on a motion by Supervisor Seifert and second by Mayor Patterson, the Board voted to accept and endorse the following recommendations of the Water Policy Committee:

- 1. A GSA "Working Group" be formed, independent of the SCWA Water Policy Committee, consisting of one member from each GSA eligible entity in the Solano Subbasin and one member of the Dixon Resources Conservation District, a member of the Solano County Agricultural Advisory Committee, and a member of the Solano County Farm Bureau, to develop one or more GSA governance structures for the Solano Subbasin, and to bring forward recommendations for approval to the SCWA Board.
- 2. The SCWA Board authorize staff to provide administrative support for the GSA "Working Group"

Mayor Augustine, Mayor Batchelor and Supervisor Vasquez voted no, Supervisor Thompson abstained.

Following the vote to accept and endorse the recommendations of the Water Policy Committee, the Board requested GSA Working Group members provide timely updates on the GSA Working Group's activities and progress to their respective governing bodies.

ADOPTION OF YOLO BYPASS AND CACHE SLOUGH PARTNERSHIP MEMORANDUM OF UNDERSTANDING

On a motion by Mayor Batchelor and second by Supervisor Vasquez the Board authorized Supervisor Thompson to sign the Yolo Bypass and Cache Slough Partnership Memorandum of Understanding on behalf of the Water Agency, and to represent the Water Agency, along with Mayor Richardson and Supervisor Vasquez, at the May 4, 2016 Yolo Bypass and Cache Slough Partnership Memorandum of Understanding signing ceremony to be held at the Crocker Art Museum in Sacramento.

WATER AGENCY STAFFING

On a motion by Supervisor Spering and a second by Mayor Patterson the Board unanimously approved two new positions; an Assistant Water Resource Specialist, and an Accountant I; and authorized staff to begin recruiting for both positions.

COMPENSATION AGREEMENT

This COMPENSATION AGREEMENT (this "Agreement") is entered into as of the 11th day of March, 2016 (the "Effective Date"), between CITY OF DIXON, a California municipal corporation ("City"), and Solano County Water Agency, the Other Taxing Entity ("OTE") with reference to the following.

RECITALS

- A. The Redevelopment Agency of the City of Dixon (the "Redevelopment Agency") was activated by the City Council of the City of Dixon (the "City Council") as a Redevelopment Agency under the California Community Redevelopment Law (Health & Safety Code Section 33000 et seq.).
- B. On June 28, 2011, the California Legislature enacted, and the Governor signed, Assembly Bill 26 from the 2011-12 First Extraordinary Session of the California Legislature ("ABx1 26") to dissolve all redevelopment agencies in the State of California.
- C. On January 11, 2012, and pursuant to Health and Safety Code Section 34173, the City Council affirmed that the City would act as Successor Agency (the "Successor Agency") for the dissolved Redevelopment Agency, effective February 1, 2012.
- D. On June 27, 2012, the California Legislature enacted, and the Governor signed, Assembly Bill 1484 ("AB 1484"), which, among other things, made certain revisions to certain of the statutes added by ABx1 26.
- E. The Successor Agency is responsible for implementing ABx1 26 and AB 1484.
- F. The Oversight Board of the Successor Agency of the City of Dixon ("Oversight Board") has been established to direct the Successor Agency to take certain actions in connection with the winding down of the affairs of the former Redevelopment Agency.
- G. Pursuant to Health and Safety Code section 34191.5, added by AB 1484, the Successor Agency prepared a Long-Range Property Management Plan ("LRPMP") addressing the disposition and use of the real property of the former Redevelopment Agency (the "Property").

- H. The LRPMP proposed for the Successor Agency to transfer the Property to the City for future development with private commercial lessees who would not be eligible for property tax exemption, thereby ensuring that during the time of City ownership OTE and other "taxing entities" (as defined in Health and Safety Code section 34171(k)) would receive their proportionate share of future property tax revenue.
- In response to a written request by the DOF made in connection with the DOF's review of the LRPMP, the Oversight Board adopted Oversight Board Resolution No. 14-002 on March 11, 2014, directing the Successor Agency to obtain compensation agreements with OTE and the other taxing entities pursuant to Health and Safety Code section 34180(f) at such time as City sells the Property.
- J. City has sold, intends to sell, or is in escrow to sell, the Property, and now wishes to enter into this Agreement with OTE to pay to OTE its proportionate share of the sales proceeds received, or to be received, by the City, in connection with said sale, as determined pursuant to Health and Safety Code section 34188. The purchase price is \$160,000.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING RECITALS, WHICH ARE INCORPORATED BY THIS REFERENCE, AND THE MUTUAL PROMISES CONTAINED IN THIS AGREEMENT, THE PARTIES AGREE AS FOLLOWS:

AGREEMENT

- 1. <u>Payment to OTE of Proportionate Sales Proceeds</u>. Within fifteen (15) days after the close of escrow pursuant to which City sells and conveys fee title to the Property, City shall pay to OTE OTE's proportionate share of the sales proceeds received by the City in connection with said sale, as determined pursuant to Health and Safety Code section 34188.
- 2. <u>Time</u>. Time is of the essence of this Agreement.
- 3. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same Agreement per taxing entities on Exhibit A.
- 4. <u>Governing Law</u>. This Agreement shall be governed by, and construed and enforced in accordance with, the internal laws of the State of California, without regard to conflict of law principles.
- 5. <u>Entire Agreement</u>. This Agreement contains the entire agreement between the parties respecting the matters set forth in this Agreement, and supersedes all prior agreements between the parties respecting such matters.

- 6. <u>Non-liability of City Officials and Employees</u>. No member, director, officer, official, employee, or volunteer of City shall be personally liable to OTE, or any successor in interest, in the event of any default or breach by City or for any amount which may become due to OTE or successor, or on any obligation under the terms of this Agreement.
- 7. <u>Successors and Assigns</u>. All the terms, provisions and conditions of this Agreement shall be binding upon and inure to the benefit of the parties and their respective successors, assigns and legal representatives.
- 8. <u>No Third Party Beneficiaries</u>. No person or entity other than City and OTE, and the permitted successors and assigns of each of them, shall be authorized to enforce the provisions of this Agreement

Water Supply Outlook Continues to Improve

As of this writing Lake Berryessa storage is at 65 percent of capacity -1,037,685 acre-feet - and almost identical to what was held in storage a year ago. The 2016 rainy season is essentially over and lake levels are just beginning to decline in response to increased water withdraws. As noted in previous reports, there is currently sufficient water in storage to meet full contractual deliveries over the next several years. Last month I reported that the State had increased North Bay Aqueduct allocations by 20 percent, from 40 percent to 60 percent of the full Table A amount. The State has once again increased the North Bay Aqueduct allocation – it is now 75% of the full Table amount.

Water Conservation Mandates

On April 20, 2016 the State Water Resources Control Board held an Urban Water Conservation Workshop to solicit public input on the emergency water conservation mandates currently in place. The workshop was well attended and there where extensive comments, particularly from water purveyors in Northern California, where rainfall was at or above normal for the first time in several years. As of this writing the State Water Resources Control Board has not reacted to the comments received, and it is therefore unclear what, if any, relaxing of the current emergency water conservation mandates will occur. However, it now appears unlikely that the State Water Resources Control Board will consider adopting the current emergency water conservation mandate or some variant of the current mandate as a permanent statewide regulation – at least this year.

Speaking of water conservation, I want to congratulate the winners of this year's 2016 Water Awareness Video Contest. First place went to Leda Brockman of Rodriquez High School in Fairfield, second place to Jethro Peralta, also of Rodriquez High School, and third place to Angeles-Sofia Rivera and Angelica Mendez of St. Patrick-St. Vincent High School in Vallejo. 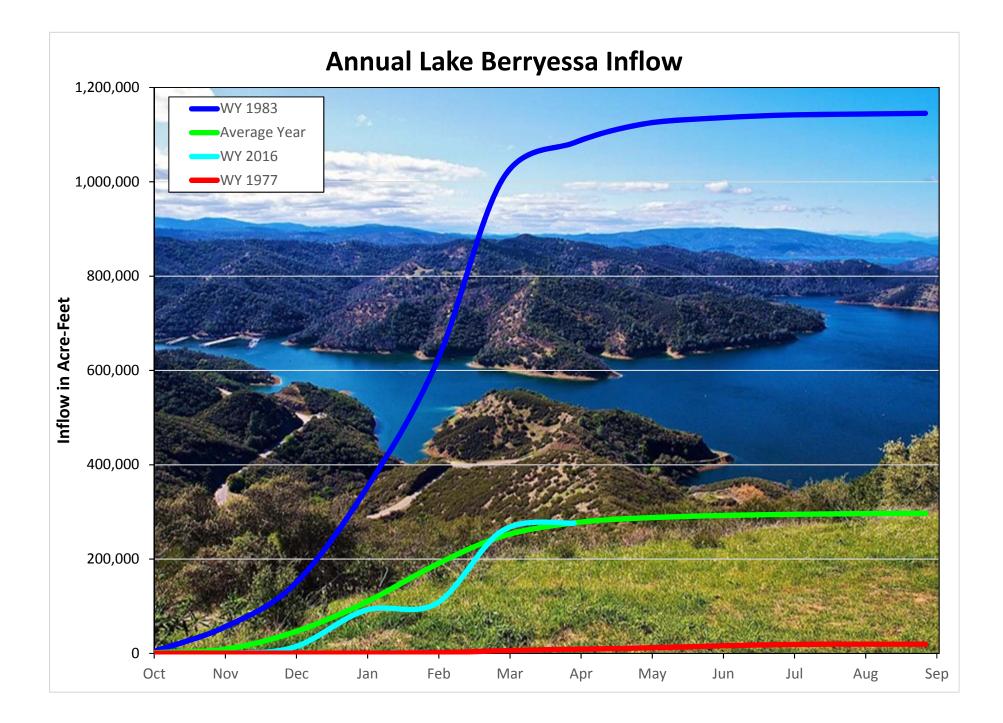
2016-2017 Budget

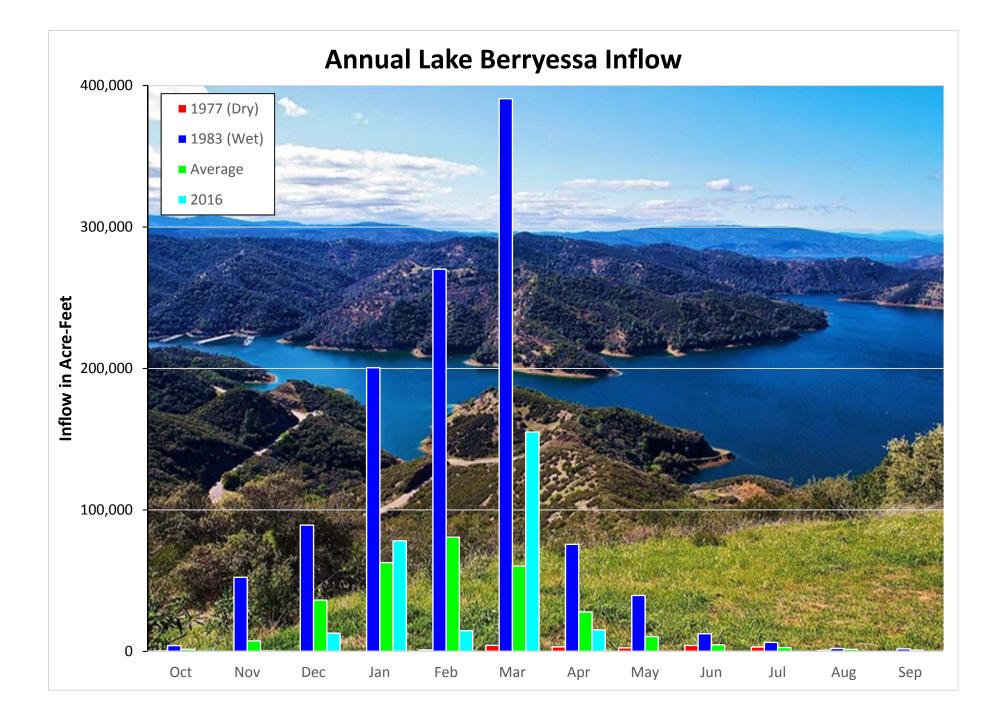

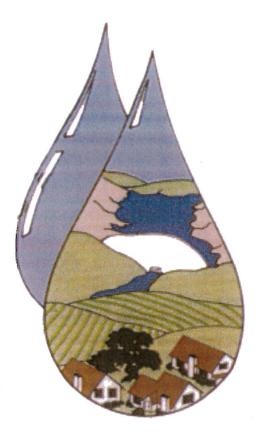
Welcome New Hires

General Manager's Budget Message

Year End Projections for FY 2015/2016

Pursuant to Board direction, the FY 2015/2016 was formulated and adopted with the expectation that \$2,744,791 would be taken from reserves to cover anticipated expenses – thereby reducing total Water Agency reserves from \$39,372,054 to \$36,627,263. Due in part to larger than anticipated revenues, staff anticipates ending FY 2015/2016 with a \$1,271,424 surplus as opposed to the originally budgeted and approved \$2,744,791 deficit. These estimates do not include a possible land purchase that was not included in the original budget, but could occur in the current fiscal year. Should the land purchase occur as anticipated, the net effect would be a budget deficit of approximately \$5,700,000 at the close of FY 2015-2016, and a corresponding end-of-year reserve balance of approximately \$33,600,000.

The following tables summarize the fiscal condition of the four budget funds; Admin-Solano Project-WM, State Water Project, Ulatis Flood Control, and Green Valley Flood Control that comprise the Water Agency's FY 2015-2016 budget, and incorporate the anticipated land purchase noted above.

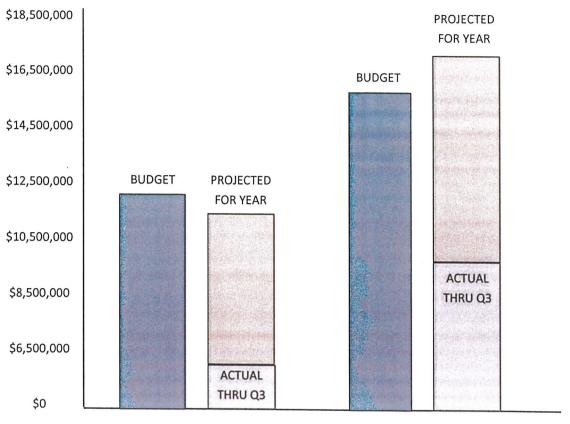

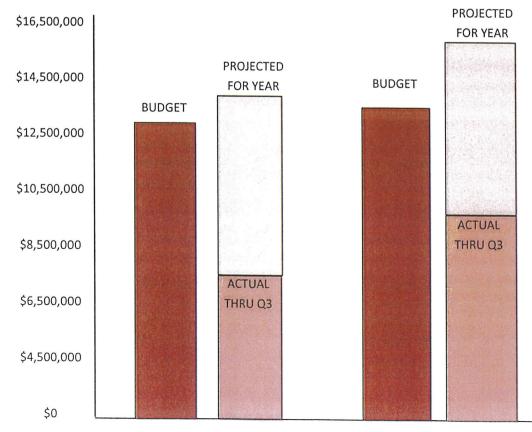

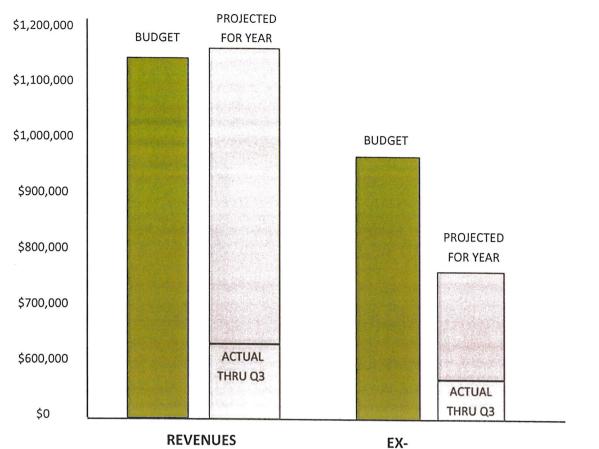
STATE WATER PROJECT



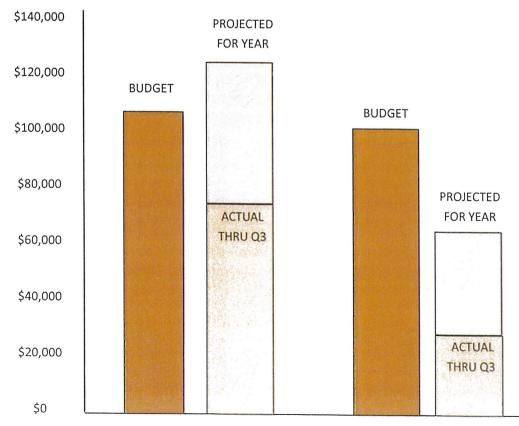

FUND PURPOSE

This fund is comprised of three distinct sub funds including Solano Project. Because the tax revenues for Solano Project are not solely restricted to that purpose, this fund acts as the General Fund of the Agency.

FUNCTION AND RESPONSIBILITES

<u>Administration</u> – The Administration division facilitates human resource and financial services of the Agency and provides support to staff in their roles of water resource planning and management, flood control, habitat conservation, grant administration and water conservation. The Administration division also includes flood control, groundwater monitoring, and water conservation activities.

<u>Solano Project</u> - The Solano Project provides about half the municipal water supply and a majority of the agricultural water supply in Solano County. The Agency protects and maintains the reliability and quality of the water supply and operates and maintains Monticello Dam, Putah Diversion Dam and 33 miles of water distribution infrastructure. Solano Project also supports The Putah Creek Accord and the work of the Lower Putah Creek Coordinating Committee.

Watermaster – The Watermaster services the Water Right Holders of the Lake Berryessa Watershed.

FUND DETAIL COMMENTS

Revenues

- <u>Property Taxes</u> The Secured, Unsecured, Supplemental, and Homeowners Relief projected year end revenues increased 6% from the Approved Budget. The Redevelopment Property Taxes increased 7% from the Approved Budget. The combined effect on total property taxes is a 6% increase, or \$478,870, due to higher assessed property values and larger redevelopment pass thru amounts.
- <u>Grants</u> Grant revenues will be less than budgeted. The Lower Putah Creek Coordinating Committee grant revenues and grant expenditures are decreased 80%, with no net effect on the budget, due to permitting delays. The Boating & Waterway Grant and the Cities Oil Grant are lower than expected due to timing issues.
- <u>Investment Income</u> Investment Income increased from the Adopted Budget by 66% due to increased interest rates.
- <u>InterFund Cost Allocation</u> InterFund Cost Allocation is 14% lower than Budgeted, primarily because of lower overhead costs due to efficiencies.
 <u>Other Revenue Sources</u> –Other Revenue Sources projected are 36% above the Adopted Budgeted due the start

of Round 3 of the water conservation grant.

Expenditures

• <u>Operations and Maintenance</u> - Operations & Maintenance Year-End Projection costs are 8% lower than the Adopted budget due to dry year conditions. SCWA did not have to replace as many Flood Station and Water Quality Instruments as projected.

- <u>LPCCC Operations</u> LPCCC is catching up on deferred maintenance and fabricating new equipment for fish
 rescue and weed spraying. The Nursery converted to drip irrigation and the greenhouse evaporative cooler was
 repaired.
- <u>Grant Expenditures</u> Grant Expenditures for LPCCC grants are lower due to reduced construction work because of permitting and other scheduling issues.
- <u>Water Conservation</u> Water Conservation costs are expected to be 14% above the Adopted Budget due to the on-going drought which has created an unprecedented level of demand on all conservation programs.
- <u>Flood Control</u> The Flood Control Year-End Projection is \$550,124 less than the Approved Budget due to the deferral of the Dixon Regional flood control project of \$500,000 and because of a dry weather year.
- <u>HCP Planning</u> HCP Planning Year-End Projections are below the Adopted Budget by \$120,084, due to timing delays with the EIR/EIS.
- <u>Consulting Expenses</u> Year-End Projections for Consulting expenses are 6% above the Approved Budget, due to the start of Sustainable Ground Water Management program.
- Fixed Assets Fixed Assets increased due to an anticipated land purchase acquisition.

PURPOSE

This fund is for all expenses and revenues associated with SCWA's State Water Project water supply. There is a dedicated property tax for State Water Project related expenses.

FUNCTION AND RESPONSIBILITES

SCWA is responsible for purchasing wholesale water from the State Water Project via the North Bay Aqueduct. SCWA administers the State Water Project contract with the State. The Department of Water Resources owns, operates, and maintains the Aqueduct. The Department's operation, maintenance, and capital costs are paid by SCWA. SCWA also performs various studies and monitors water quality in the Barker Slough. A major project is the development of the NBA Alternate Intake Project.

FUND DETAIL COMMENTS

Revenues

- <u>Property Tax Revenues</u> The Secured, Unsecured, Supplemental and Homeowners Relief year end revenues are projected to be \$1,220,871, 12% above the Approved Budget amount of \$10,139,122, due to increased assessed property values.
- <u>Water Sales</u> Water Sales revenues are just slightly lower than budgeted, 5%, due to lower power cost reimbursement to pump NBA water.
 <u>Grant Revenues</u> Grant revenues will be less than budgeted. The NBA Alternate Intake project work

performed by the State was slower than expected resulting in a decrease in grant revenues of \$140,679.

<u>Investment Income</u> – Investment Income increased due to increased interest rates.

Expenditures

- <u>Operations and Maintenance</u> Expenses are 52% lower than budgeted primarily due to the Barker Slough Management Project being delayed, not having conducted as much water sampling as planned, and a reduction in the Labor & Overhead charges from staff time spent on other projects.
- <u>Grant Expenditures</u> Projected Grant expenses are less than budgeted for reasons cited above "Grant Revenues". The NBA Alternate Intake expenses decreased by \$622,000.
- <u>Consultants</u> Consulting expenses decreased by 50%, because of delays of the NBA Capacity Study to FY 2016-2017, and delays with the Yolo Bypass Management project.
- <u>Fixed Assets</u> Fixed Assets increased due to an anticipated land acquisition.

FUND PURPOSE

This fund appropriates tax revenues for performing maintenance functions on the Ulatis Flood Control Project.

FUNCTION AND RESPONSIBILITES

The Ulatis Flood Control Project was constructed by the Soil Conservation Service, then turned over to SCWA to maintain, providing flood protection of agricultural land within and downstream of Vacaville. Solano County Channel Maintenance staff perform the routine maintenance duties, while SCWA provides engineering, administration, and right of way management.

FUND DETAIL COMMENTS

Revenues

- <u>Property Taxes</u> The Secured, Unsecured, Supplemental and Homeowners Relief Tax Revenues are
 projected to be \$41,840, or 5%, above the Approved Budget due to higher assessed property values. The
 Redevelopment property taxes are projected to be \$24,533 below the Approved Budget due to lower
 redevelopment pass thru amounts. The overall effect is a net increase of \$17,307 or 2% in property tax
 revenues.
- <u>Investment Income</u> Investment income increased due to higher interest rates.
- <u>Other Sources</u> Services provided to Dixon were lower than anticipated.

Expenditures

- <u>Supplies and Services</u> Property Tax Administrative fees were less than anticipated.
- <u>Operations and Maintenance</u> Projected Year-end expenses are \$141,874 lower than the Adopted Budget because in dry years less maintenance and repair work is needed on flood control channels.
- <u>Rehab & Betterment</u> The Rehab & Betterment expenses were not incurred due to another dry year.
- <u>Fixed Assets</u> Fixed Assets is \$5,554 under budget as the cost of a backhoe was slightly lower than expected.

FUND PURPOSE

This fund is comprised of tax revenues and is appropriated to perform maintenance of the Green Valley Flood Control Project.

FUNCTION AND RESPONSIBILITES

The Green Valley Flood Control Project was constructed by the Corps of Engineers then turned over to SCWA to maintain. The Project provides flood protection of lands in Fairfield and areas downstream of Fairfield. Solano County Channel Maintenance staff perform routine maintenance, while SCWA provides engineering, administration, and right-of-way management.

FUND DETAIL COMMENTS

Revenues

• <u>Property Taxes</u> - The Secured, Unsecured, Supplemental and Homeowners Relief Tax Revenues are projected to be \$4,603, 6% above the Approved Budget amount of \$71,864. The Redevelopment Tax is projected at \$46,834, 34% over the Approved Budget amount of \$34,915. This 15% overall tax increase is due to higher assessed property values and redevelopment pass thru amounts.

Expenditures

- <u>Operations and Maintenance</u> Projected Year-end expenses are \$24,234 lower than the Adopted Budget because in dry years less maintenance and repair work is needed on flood control channels.
- <u>Rehab & Betterment</u> Rehab & Betterment expenses are projected to be \$10,000 less than the Adopted Budget of \$10,000 due to another dry year not requiring these services.

BACKGROUND:

Pursuant to the 2014 Sustainable Groundwater Management Act (SGMA), the Yolo County Flood Control and Water Conservation District (YCFCWCD), on behalf of the Water Resources Association of Yolo County (WRA) and the Yolo Farm Bureau has submitted a Basin Boundary Modification proposal to the California Department of Water Resources (DWR) that if approved, would among other things, adjust portions of the Solano Subbasin boundary. In very general terms, the YCFCWCD is proposing to adjust the current Solano Subbasin boundary to more closely align with the Solano/Yolo county boundary. A summary of the YCFCWCD proposal is attached, additional information can be obtained at www.yologroundwater.org.

As a part of the basin boundary modification process specified by SGMA, DWR is seeking comments on YCFCWCD's proposal. Comments and documents in support or opposition to the YCFCWCD proposal must be submitted to DWR by no later than May 13, 2016. Support or opposition to the proposed basin boundary modification must be articulated either in the form of a resolution from the decision making body or a letter signed by the executive officer or official with appropriate delegated authority.

Staff has not identified any overwhelmingly strong arguments – technical or policy oriented – in support or opposition to the YCFCWCD proposal, due in part to the somewhat limited hydrogeologic information pertaining to the geographic areas in question, and perhaps more importantly, the lack of information pertaining to the future land uses and/or agricultural activities that may occur in and near the affected geographic areas (for additional information see attached copy of "Evaluation of Yolo Boundary Modification Application" prepared by Solano County Department of Resource Management, dated April 28, 2016). Given the incomplete understanding of the hydrogeology and the limited ability to project long term land use activities, staff believes the merit or demerits of the YCFCWCD proposal will ultimately be determined by the nature and scope of the coordinating agreements that are developed between the Solano and adjacent groundwater subbasins. Staff recommends conditional support of the YCFCWCD proposal – support with the expectation that a robust coordinating agreement will be developed between the Solano and adjacent groundwater subbasins.

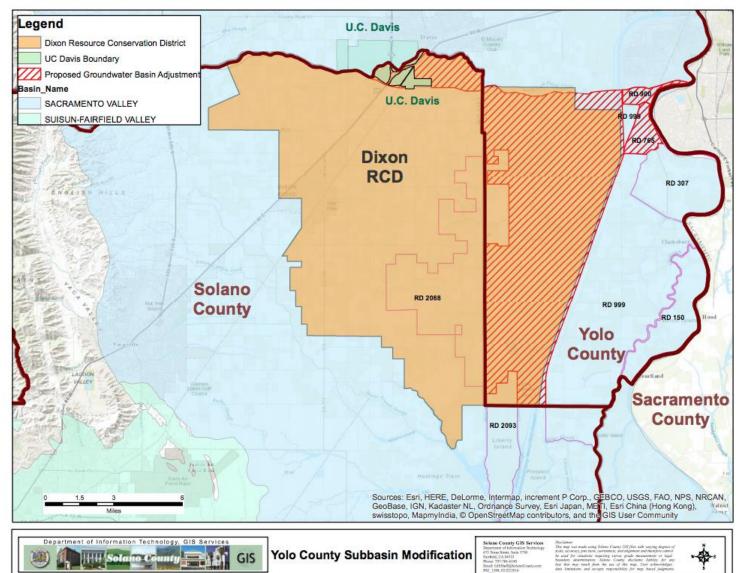
The Yolo County Flood Control and Water Conservation District (District), on behalf of the Water Resources Association of Yolo County (WRA) and the Yolo County Farm Bureau (Farm Bureau), has submitted an initial notification to the California Department of Water Resources (DWR) to explore a basin boundary modification; pursuant to Section 343.9 of <u>DWR's Groundwater Basin Boundary</u> <u>Regulations</u>. The proposed basin boundary modification is a jurisdictional modification involving a consolidation of the Capay Valley (5-21.68) and portions of the Colusa (5-21.52), Yolo (5-21.67), and <u>Solano</u> (5-21.66) subbasins that lie within Yolo County and a boundary adjustment along the Yolo County line. The modification would create a new subbasin called the Yolo subbasin, or Yolo Basin. <u>You can</u> see the details of this notification on Yolo's groundwater website.

See the attached map for a visual presentation of the proposed changes impacting Solano County/Solano subbasin. Changes include:

- Modifying the Yolo subbasin near the UC Davis campus. The proposal includes keeping the Solano County portion of the UC Davis campus lands within the Yolo subbasin. Other land adjacent to the UC Davis Campus that is in Solano County but currently in the Yolo subbasin, will be integrated into the Solano subbasin.
- Keeping Reclamation Districts 2068 and 2093 wholly within the Solano Subbasin, and not splitting their service areas between two different basins.
- Expanding the Yolo subbasin into some areas currently identified in the Solano subbasin that are within Yolo County.

The District intends to submit a formal basin boundary modification request to DWR by March 31, 2016. Once the formal request is deemed complete by DWR, the public will be given a 30-day public comment period.

Dear Mr. O'Halloran:

The Solano County Water Agency (SCWA) recognizes that much like Solano County, groundwater is a vital resource in Yolo County. Current groundwater management activities in Yolo County encompass all or part of four subbasins identified in the California Department of Water Resources (DWR) Bulletin No. 118: Colusa (5-21.52), Solano (5-21.66), Yolo (5-21.67), and Capay Valley (5-21.68) subbasins.

SCWA is aware of the Yolo County Flood Control and Water Conservation District's (District) proposal to the California Department of Water Resources (DWR) to modify and consolidate the basin boundaries associated with the Yolo (5-21.67), Capay Valley (5-21.68), and portions of the Colusa (5-21.52) and Solano (5-21.66) subbasins. In the case of the Solano subbasin, which is largely located within Solano County, the District is proposing to adjust the subbasin boundary to more closely align with the Solano-Yolo county boundary.

SCWA conditionally supports and recommends DWR's approval of the proposed boundary adjustments as submitted by the District, with the expectation that pursuant to the 2014 Sustainable Groundwater Management Act, the District will work closely with both Solano and Sacramento counties to develop a robust groundwater management coordinating agreement between the groundwater governance entities that are ultimately created to manage groundwater resources in the Solano and adjacent groundwater subbasins.

Basin Boundary Modification Application - The Yolo County Water Resource Agencies (WRA)¹ submitted an application to the California Department of Water Resources (DWR) to consolidate four separate groundwater subbasins within Yolo County into a single "Yolo Subbasin" that mostly conforms to the Yolo County boundary lines. DWR deemed this application complete on April 15, 2016 and a 30-day comment period is now open prior to DWR accepting the application. The application, including a map of the proposed basin boundaries and supporting information, can be found on DWR's website².

This proposal is a jurisdictional modification of boundary lines intended to promote sustainable groundwater management by building on the existing structure of the WRA and by improving efficiency between land use planning and water resources management in Yolo County.

Figure 1 is an illustration modified from a WRA presentation depicting the subbasins regulated under the Sustainable Groundwater Management Act in Yolo, Solano and Colusa Counties before and after the proposed basin boundary modification. Figure 2 provides a close up of the boundary line between the Yolo and Solano Subbasins before and after the proposed boundary modification.

GROUNDWATER CONDITIONS

Groundwater management is currently conducted by entities within their jurisdictions regardless of subbasin boundary. Through the DWR California Statewide Groundwater Elevation Monitoring (CASGEM) program, Solano County Water Agency (SCWA) is the groundwater management entity in Solano County, and WRA manages groundwater throughout Yolo County, including in the Solano Subbasin area of Yolo County.

The area proposed to be added into the Solano Subbasin consists largely of agricultural lands that rely heavily on groundwater and that have been the subject of several regional groundwater studies³. Based on available information, groundwater conditions in the area appear stable. Groundwater elevations fluctuate in response to wet and dry years, but do not exhibit long-term downward trends.

The area east of Solano County in the Solano Subbasin that is proposed to be added into the new Yolo Subbasin also is largely utilized for agricultural purposes. However, most of the irrigation water in this area is obtained from surface water sources, which is readily available through various water purveyors. Although limited, publicly available groundwater elevation data strongly suggest that groundwater conditions in this region are also stable.

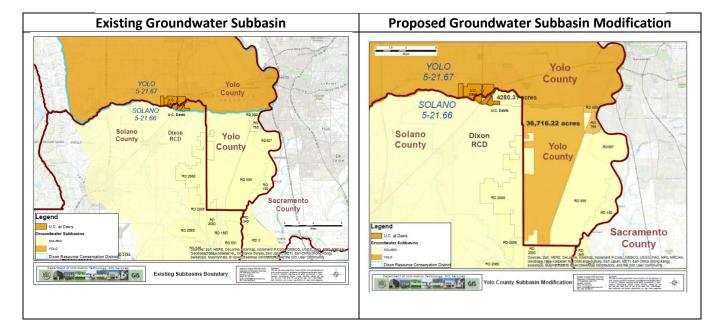


Figure 3: General Groundwater Flow Direction in the Solano Subbasin.

Based on groundwater level monitoring conducted through CASGEM, groundwater in the vicinity of the University of California, Davis and the Solano Subbasin area of Yolo County generally flows to the southeast, toward the Sacramento River. Therefore, areas in the Yolo County portion of the Solano Subbasin are considered down gradient from Solano County. Figure 3 illustrates the general groundwater flow direction within the Solano Subbasin portion of Solano County.

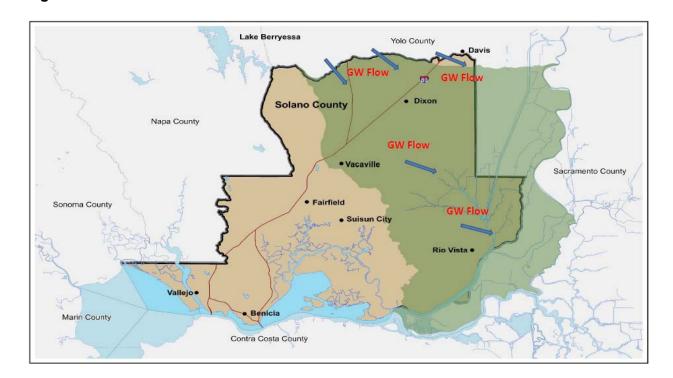


Figure 4: Map of Solano County showing soils that are suitable for groundwater recharge based on the Soil Agricultural Groundwater Banking Index (SAGBI), developed by the California Soil Resource Laboratory at the University of California, Davis.

The aquifers in the Yolo and Solano subbasins are connected and surface water recharges aquifers in both subbasins. A soil agricultural groundwater banking index⁴ (SAGBI) map developed by the California Soil Resource Laboratory at the University of California, Davis identifies soils suitable for groundwater recharge. Figure 4 illustrates the soils mapped in Solano County that have potential to recharge groundwater aquifer systems. This map shows the areas north of Dixon along the Yolo/Solano county line and along the south fork of Putah Creek extending into Yolo County as having good to excellent recharge potential. Areas along the Sacramento deep water ship channel in the Solano subbasin were ranked "poor". The SAGBI index website: http://casoilresource.lawr.ucdavis.edu/sagbi/

If DWR approves the proposed basin boundary modification, the Solano Subbasin will gain areas along the south fork of Putah Creek that may increase potential groundwater recharge for Solano County aquifers. With the exception of an area near the south fork of Putah Creek in Yolo County, the majority of soils in the Yolo County portion of the Solano Subbasin have poor recharge potential.

AFFECTED AREAS

WRA's boundary modification proposal affects the northeastern portion of Solano County, near UC Davis, in the Yolo Subbasin and the Yolo County portion of the Solano Subbasin in the following manner:

Solano County - Unincorporated property near UC Davis (just to the east of the south campus lands) within Solano County is currently in the Yolo Subbasin. The WRA modification would add these properties to the Solano Subbasin. The UC Davis campus properties in Solano County would remain in the Yolo Subbasin.

Yolo County - Property in the eastern portion of the Solano Subbasin in Yolo County would be incorporated into the new Yolo Subbasin, except for land within the boundaries of reclamation districts (RDs) RD 2068, 2093, 999, 307 and 150, which have requested to remain in the Solano Subbasin. RDs in the Delta region, including RDs 999, 307, and 150, have indicated they are exploring forming their own Northern Delta GSA.

The proposed modification would result in the following benefits and areas of concern:

1) Extension of the Solano Subbasin into the Yolo Subbasin within northeastern Solano County.

- Benefit
 - The Solano subbasin will gain lands currently in the Yolo Subbasin along the South Fork of Putah Creek that have a high potential for groundwater recharge, which will benefit the Solano Subbasin aquifers.
 - Agricultural land currently within the Yolo Subbasin will now be regulated by a GSA for the Solano Subbasin.
- **Concern** The U.C. Davis Campus within Solano County will continue to remain in the Yolo Subbasin.

• **Mitigation** – Coordination agreements will be needed with Yolo County, WRA, and U.C. Davis to coordinate management of adjacent subbasins.

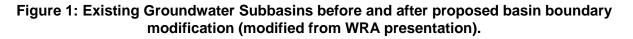
2) Extension of the Yolo Subbasin into the existing eastern portion of the Solano Subbasin.

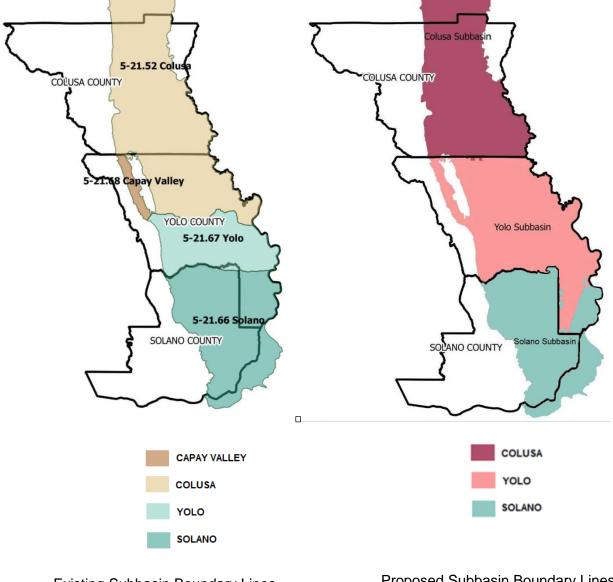
- Benefit
 - The proposal will retain the existing groundwater management of these areas, to which the local farmers and RCD are accustomed.
 - The proposal will allow for future GSA formation and subbasin boundary modification by the proposed Northern Delta GSA.
- Concerns
 - Minor concerns include losing a small potential groundwater recharge area along the south fork of Putah Creek, just east of the Solano County border.
 - Solano agencies may lose some ability to ensure that groundwater management in the existing eastern portion of the Solano Subbasin is adequately coordinated with the remaining portion of the Solano Subbasin.
 - Dixon RCD service area is bisected.
 - Mitigations
 - WRA and Yolo County are willing to enter into agreements to coordinate management of these adjacent subbasins.
 - Most of the areas downgradient of Solano County, including the existing eastern portion of the Solano Subbasin, have not been identified as having high recharge potential for groundwater.
 - The Dixon RCD board supports the modification.

<u>Submitting Comments</u> – Comments and documents to support, oppose, or remain neutral on the proposed basin boundary modification must be submitted during the 30-day comment period to the DWR website⁵. Support or opposition of the proposed modification from a local agency must include either a resolution from the decision making body or a letter signed by the executive officer or official with appropriate delegated authority, and must include similar scientific and technical information as the boundary modification request.

<u>Other Agency Involvement</u> – Of the agencies within Solano County and the existing Solano Subbasin, the Northern Delta GSA and UC Davis have each submitted letters of support, which are included in the WRA's basin boundary modification application. On April 13, 2016, Dixon RCD board voted to submit a letter of support to DWR. Staff from the Solano RCD indicated that they support the proposed basin boundary modification.

Figure 2: Close up of subbasin boundary lines between the Yolo and Solano Subbasins before and after the Yolo Subbasin Boundary modification.
