RE: REFRIGERATION UNIT - PROPOSED PURCHASE

BUDGET IMPACT: Up to \$5,000 from Nut Tree Mitigation Fund (\$80,000 remaining)

RECOMMENDATION: Approve purchase of cold storage unit at auction.

SUMMARY: This is a proposal to purchase a new refrigeration unit from Government Liquidation at auction to store bare root trees between digging/sorting and transplanting.

BACKGROUND: The LPCCC accepted \$90,000 to plant 1,000 trees on Putah Creek this year for the second phase of Nut Tree Airport mitigation plantings with two additional phases planned over the next two years. This year, like none in our experience before, cottonwoods are growing in dense thickets that can be harvested this winter as bare root trees and planted out in rows with our shade tree transplanter. Cottonwoods have been dying out in many places due to fire and drought. We have an opportunity to restore the cottonwood canopy on 70 acres of riparian habitat downstream of Putah Diversion Dam while meeting the requirements of the Nut Tree Mitigation Project. We have done similar work harvesting and transplanting wild rose. Until now we used borrowed cold storage space. Planting potentially thousands of cottonwoods requires more cold storage space. Bare root trees can be held in cold storage for several months. There are currently three Sea Box Small Field Refrigeration Units in Ohio that will be auctioned on Government Liquidation in October. In July, an identical unit sold at auction for \$1,250. These units are new according to the manufacturer, they use modern (R404A) refrigerant and all replacement parts are available. Of the three units one has zero hours and another has just six hours of use. Shipping from Ohio is estimated to cost \$3,000. New, these units list for \$23,250. This model uses highly efficient three-phase power which is available at Putah Diversion Office.
