Regarding: Nut Tree Mitigation Area - Preserving Some Results

Report

Although the Nut Tree Mitigation Area has been problematic for certain reasons including the 2017 floods, I contend that sections have been successful, although possibly in metrics not used for plant mitigation. A significant number of wildlife species have used the area for hunting, nesting and resting (deer). Per your permission, I have used the area for monitoring nesting birds that are potentially foraging in the nearby Scarification Site.

I understand that Tony Morales wanted the area mowed, but discussions with him confirmed he would have been okay with creative mowing that "outlined" specific plants that appear to be surviving. Unfortunately, someone mowed the entire area, straight down the rows, leaving irrigation materials that will have to be removed. I have briefly discussed this with Melanie Truan and Nicolle Herr and would like to proceed to see if we can salvage some of the areas identified with aerial images on the following pages. I will describe "salvage" after a site visit with Melanie and Nicolle and a plan is developed.






Image 2: Nut Tree Mitigation Area aerial image (5-2-2018) as the drone moved northeast at a constant elevation.


