### Steps to Participate

1. Read the Terms and Conditions.
2. Download Rebate Application from [www.scwa2.com/water-efficiency/rebates-programs/residential-rebates/](http://www.scwa2.com/water-efficiency/rebates-programs/residential-rebates/) or request one directly from SCWA by emailing [solanocash4grass@scwa2.com](mailto:solanocash4grass@scwa2.com) or calling 707-455-1113.
3. Submit completed Rebate Application to SCWA via mail, email, or fax. Applications will be processed as they are received until all funds are reserved.
4. Upon receipt of Rebate Application, SCWA will call or email applicant to schedule Pre-Inspection visit. Please be patient while SCWA processes applications. *Do not call SCWA to schedule a Pre-Inspection.*
5. Following Pre-Inspection, await receipt of Application Approval letter by email or mail. **Do not remove lawn until you receive this document.** *To be eligible for a rebate, the Lawn Conversion Project must not be started before receipt of an Application Approval.* Due to high demand, you may be approved and placed on a waitlist pending fund availability.
6. Remove the lawn area and install your project according to the program Landscaping Requirements for Converted Area listed in the Terms and Conditions **within 120 days.**
7. **Schedule a Post-Inspection visit when project is complete** (call SCWA at 707.455.1113 or email [solanocash4grass@scwa2.com](mailto:solanocash4grass@scwa2.com)). **Post-Inspection must take place within 120 days of the Application Approval.** If project is not complete within 120 days application will be terminated.
