## April 14, 2022, LPCCC Meeting Minutes. Meeting by Zoom and In-Person (hybrid)

### 4. Wildlife Monitoring Review:

Melanie Truan was unable to attend and give the presentation on the Putah Creek Nestbox Highway Monitoring. Instead, Streamkeeper Stevenson presented a brief summary of the 22 years of Nestbox monitoring results with an overview of 18 other active fish and wildlife monitoring programs on Putah Creek. A table of the 19 wildlife monitoring programs was reviewed. Suggestions from the Committee included expanding the table to include information on period of record (time span), ongoing vs. completed, and frequency, for each monitoring program.

# 5. Three Year Plan for Riparian Diversions:

Observations of flow downstream of I-80 were discussed.

- 1. Landowners on the Creek have a right to pump riparian water.
- 2. Pumping after July 15 is usually not riparian.
- 3. All pumping (>10 AF/yr) is required to be measured and reported to the State.
- 4. Lisbon Weir gage often shows Toe Drain negative flows July-Aug and Sept-Nov (-50 to −100 cfs)
- 5. Creek flows include: ag returns, wheeling, sales from YCFC
- 6. Putah Creek salmon use the Toe Drain
- 7. Drought, Low DO, Fish Passage issues exist

The Riparian Forecast Model was also discussed. The Forecast is required as part of the Accord. The State Water Rights website, eWRIMS, was briefly presented as a future activity to investigate.

#### Next Steps:

- 1. Improve Flow Monitoring
- 2. Tighten Up Accord Obligations at the Toe Drain
- 3. Engage the Water User and Regulatory Communities in the Bypass
- 4. Research and Summarize Current Water Rights
- 5. Formalize Low Dissolved Oxygen Emergency Response Plan
- 6. Pursue Funding for Projects, such as Putah Creek Realignment (not just a fish bypass)

### 6. Annual Workplan:

Stevenson reported that he met twice with Wimmer and once with Huber on the Annual Workplan Development. The LPCCC Planning subcommittee also met once on the Annual Workplan. The Workplan is still in draft, was not presented, and a more developed plan will be presented at the next LPCCC meeting.
