1. Remote Meeting Action Item: Government Code Section 54953(e) added by Assembly Bill 361 requires that teleconferencing be approved by governing boards each month.

4. Solano RCD Presentation:

Chris Rose, Executive Director of the Solano RCD gave a outreach presentation funded by the Solano Orderly Growth Committee. Rose discussed the role of the RCD as in Solano County (Dixon, Solano, and Suisun RCDs) and the creation of a map-based database of potential new restoration and/or resources protection projects. This list of potential projects will be used when funding becomes available in the future. Projects include wildfire prevention and post fire recovery. Maps of Solano County Fire Safe Councils were presented. The education mission of the RCD (11,000 students in 2021) and general funding sources were also discussed. Private landowner liability protection is through individual landowner agreement and RCD insurance. Solano RCD may join a Prescribed Burning Association in the future.

5. Riparian Diversion Update:

This item was pulled from the agenda pending collection of more information.

6. Putah Creek Realignment in the Yolo Bypass and Fish Bypass at the Los Rios Check Dam

Potential solutions to barriers to fish passage were discussed: Los Rios Check Dam Northern Bypass (1,600 feet) and Putah Creek Southern Realignment (4 miles). The Northern Bypass is conceptual currently. No funding has been identified yet.

The Southern Realignment Project was part of a large multi-year planning effort (~\$500,000) led by the Yolo Basin Foundation and completed in 2016. Engineered drawings and CEQA are mostly complete. https://resources.ca.gov/CNRALegacyFiles/docs/ecorestore/projects/Lower_Putah_Creek_Realignment.pdf Dissolved oxygen and timing were discussed. There is potential for funding the project with Voluntary Agreements funds to improve fish habitat (https://files.resources.ca.gov/voluntary-agreements/). This would be a 3-to-5-year project. The LPCCC asked what the Committee could do to support the project. A draft support letter will be brought to the Committee at the next meeting.
