Sept 8, 2022, LPCCC Meeting Minutes. Meeting by Zoom

1. Remote Meeting Action Item: Government Code Section 54953(e) added by Assembly Bill 361 requires that teleconferencing be approved by governing boards each month. It was decided unanimously during the July 14, 2022 meeting, that future meetings will also be remote, except for one in-person meeting in the fall. Chair Huber waived discussion on this item.

4. Review Timing of Fall Attraction Flows

Data from the DWR Toe Drain Fish Monitoring Program was presented showing arrival timing of Fall Run Chinook Salmon. The fall attraction pulse flow is being moved earlier than year's past, to better match when the fish arrive. The fall attraction flow for this year is tentatively scheduled for Oct 24-29, 2022. Final coordination of removal of the Los Rios Check Dam Boards and barriers at the County Rd 106a Crossing are still pending.

The drought has impacted flows in the Toe Drain north of the Putah Creek confluence. There is no continuous flow to the Wallace Weir Fish Rescue Facility. Any salmon that would normally make it to the Fish Rescue Facility (600 in 2020) will not have any good place to go, except Putah Creek.

A motion was made by Fulks for the LPCCC to support the Oct 24-29, 2022 pulse flow schedule. Seconded by Wimmer. Ayes: Unanimous

The LPCCC requested that Fall Attraction Flow discussion item be added to the Pattern Calendar for future years in August. The multiple obligations of SCWA staff at this time of year and how they relate to scarification and pulse flow work were also discussed.

5. LPCCC Planning Subcommittee Report

A short update was presented by Wimmer. Wimmer explained that the Putah Creek Water Management (PCWM) will address the entire Creek. A developed plan will be brought to the full LPCCC at the October 2022 meeting. Stevenson also presented a history of Solano Projects releases into Putah Creek.

6. Pattern Calendar

Grant Project Updates. Nishikawa is ongoing (\$750,000 from the State and cost share from SCWA). The Streamkeeper confirmed that three fish passage projects on Putah Creek (LRCD Northern Bypass, CR106a Bypass, Putah Creek Southern Realignment) are on the official list of restoration projects for "Voluntary Agreements" process. https://voluntaryagreements.org/ The Streamkeeper stated that more time and resources are needed to apply for grants. Wimmer and the LPCCC requested a plan for more resources dedicated to grant applications be presented at the next LPCCC meeting.

Annual Report to the Court. The report is due to be submitted in the next few months. In recent years the Reports have been a single page in 'fact sheet' style. Kluge asked if anyone reads the report. There was discussion on the value of the report as an obligation from the Accord, as a tracking device, and its use as a legal record. Kluge agreed that it was valuable for the LPCCC, but questioned the value of sending to the Court, when the original judge has retired.

Riparian Diversion Process. Although this item is annually listed on the calendar, this topic is covered every month in the Water Conditions Report from the Streamkeeper. This item will be covered later in the meeting.
