

Commercial Toilet Rebate

Get up to \$300 back on the purchase and installation of each new, WaterSense labeled high-efficiency flushometer-valve toilet, tank toilet, or urinal. Replacing or upgrading outdated and inefficient fixtures can help you save water and money!

Applies to purchase of qualifying flushometer-valve toilets, tank style toilets, and urinals

- Rebate of \$300 per toilet, maximum of 50 toilets
- Must be replacing 3.5gpf or higher toilet
- New toilet must be 1.28 gpf or less
- New urinal must be replacing 1.5 gpf or higher
- Must provide proof of purchase within 120 days of purchase
- SCWA reserves the right to inspect toilets

Eligibility

- Property must belong to the water account holder or must have written permission from the property owner.
- Residential properties do not qualify for this rebate.
- This program is first come, first served and dependent upon limited funding availability.

Program Details

• Flushometer-valve toilets, urinals, or tank toilets must be WaterSense labelled/certified.



- The flushometer-valve toilets or tank toilets that you are planning to replace must be designed to flush at 3.5 gallons per flush or more.
- New toilets must be purchased and installed within 120 days of application
- All purchases must be made between January 1, 2024 to June 30, 2024.
- New flushometers-valves toilets or tank style toilets must be 1.28 gallons per flush or less (not recommended below 1 gallon per flush)
- New urinals must be replacing 1.5 gallons per flush or higher. Eligible urinals must be HEUs that are .5 gallons per flush or less.
- SCWA staff must approve application prior to installation of new toilet.
- SCWA reserves the right to conduct a pre-inspection site visit prior to approval.
- SCWA also retains the right to conduct a final inspection to ensure that toilets/urinals were installed.
- A completed and signed IRS FORM W-9 is required for any rebate of \$600 dollars or more per IRS regulations. A 1099-MISC form may be issued if combined rebates incentives from Solano County Water Agency exceed \$600 per tax year.
- Incomplete applications and those submitted without a completed IRS Form W-9 or a copy or purchase receipts will not be approved.

Rebate

- The rebate will cover up to \$300 per toilet not including taxes, installation, or labor costs.
- Maximum of 50 toilets eligible per the lifetime of the account.
- Eligible WaterSense Toilets found here:
 - Toilets
 - Flushometer-valve toilets
 - Urinals
- Rebate will not be applied to purchase made with gift cards.
- Rebate is applied to purchase price before tax and shipping.
- SCWA retains the right to perform a site visit if requested.
- Rebate may be combined with other agency rebates (Water Efficient Landscape Rebate, Commercial Customized Rebate Program, etc.
- REBATE DOES NOT INCLUDE LABOR COSTS FOR INSTALLATION

The applicant waives and releases SCWA, participating water utilities, and their contractors or agents from all claims and causes of action arising from the installation of high efficiency toilets or urinals.
