

Water Conserving Products Terms & Conditions

- Only qualifying products purchased <u>on/after July 1, 2023</u>, are eligible for a rebate. No exceptions.
- Limited time offer: Rebates are offered on a first-come, first-served basis and are subject to availability of funds. This program shall always be subject to change or termination without prior notice.
- Rebates cover the cost of qualifying products, up to *\$50* per product category excluding tax, delivery, and labor.
- Limit: one (1) rebate per product category per household up to a maximum of five (5) rebates total for the life of the program; substitutions not allowed.
- Must include copies of:
 - Purchase receipt within 180 days of purchase.
 - Most recent water bill (for verification of residency in Solano County)
- Rebates are for the following products: swimming pool covers, hot water recirculating system electric pumps and thermal bypass valves, 3-way diverter valves and air vents for laundry-to landscape graywater systems, rain barrels and cisterns to harvest rainwater. Products must be new; recycled or secondhand products do not qualify. Additional information about eligible products are available on our website at scwa2.com/residential rebates.
- Offer applies to single-family and duplex residential customers only. Commercial and multi-family residential properties do not qualify.



- The rebate program is open to Solano County Water Agency residential customers who have property with existing single family residential dwellings within the service area. Renters or tenants must have written approval from the property owner.
- Rebates will be paid to the name as it appears on the water bill unless applicant is not the water account holder.
- A copy of the original receipt(s) must be submitted with the application. The receipt must list manufacture, model, and purchase date. Original receipts must be readable rebate applications processing may be delayed if the receipt is not clear. Receipt must be submitted to our Agency within 180 days of purchase.
- Incomplete and unsigned applications will not be approved.
- Solano County Water Agency reserves the right to request proof of installation and/or to inspect the property to verify that the product(s) is (are) installed, either before or after rebate is paid.
- Customers are responsible for complying with all applicable codes and regulations.
- The Solano Water Rebate Program is not responsible for materials lost or destroyed in transit through the mail.
- Submission or possession of a rebate application does not guarantee receipt of a rebate.
- Funding for this rebate program is limited to available resources.
- Allow six to eight weeks for processing of rebate checks.



Eligible Water-Conserving Products

The following water-conserving products are eligible for a rebate. Products that are parts of these systems but not listed here are not eligible. To qualify, products must be new and installed at single-family or duplex residential properties where water service is provided by a city utility. Rebates cover the cost of the product **up to \$50 per product category**, excluding tax, delivery, and labor. **Limit: ONE rebate per product category per household for the life of the program.**

Product Categories

POOL COVER

Rebates are for new covers specifically made for pools. Rebates do not apply to secondhand covers, mesh covers, chemical/liquid covers, or spa covers.

HOT WATER RECIRCULATING SYSTEM COMPONENTS

Eligible components include electric pumps and thermal bypass valves that create one continuous water supply loop to recirculate water throughout the home.



LAUNDRY-TO-LANDSCAPE SYSTEM COMPONENTS

Eligible components include a 3-way diverter valve to direct the flow of graywater to the landscape or to the sewer, and/or an air vent to prevent accidental siphoning of water from the clothes washer. Product must be installed as part of a residential clothes washer and meets all requirements for graywater systems as described in the California Plumbing Code. Other system components, including tubing, plumbing parts, outlets, mulch shields, and components installed as part of more complex graywater systems, **do not qualify**.

RAIN BARREL

Only finished containers sold exclusively for rainwater collection are eligible. Secondhand or self-made rain barrels **do not qualify**. Barrels must have fixed screens and safety covers that prevent entry of children, mosquitoes, and animals.

RAIN SENSORS

To qualify for the rebate, the rain sensor must be set to shut-off the irrigation system when it detects 1/8-inch or more precipitation.

REBATE AGREEMENT- RELEASE OF LIABILITY

Rebates are one-time-only per site, and will be provided on a first-come, first-served basis. Rebates offered are subject to availability of funds. This rebate program may end at any time. SCWA reserves the right to deny any application that does not meet all requirements outlined above. Due to variables beyond the control of SCWA, the Agency cannot guarantee the installation of WBICs will result in a lower utility bill. The applicant waives and releases SCWA, participating water utilities, and their contractors or agents from any and all claims and causes of action arising out of the installation and use of this product. SCWA is not responsible for any damage that may occur to participants' property as a result of the program.
