- 3. Public Comment: No formal public comments. Some technical difficulties with zoom were discussed.
- **4. Pattern Calendar –** The pattern calendar for February was reviewed.
  - 1. Riparian Diversion Updates covered in PCWM agenda items
  - 2. Interagency Communication Updates special guess Garrett Spaan was introduced. He is the new manager of the Yolo Bypass Wildlife Area (YBWA). The lower 3 to 4 miles of Putah Creek is located in the YBWA.
  - 3. Fish Monitoring Updates Tim Salamunovich os the Two categories of fish montiriiung on Putah Creek (salmon and everything else). An overview table of salmon and non-salmon fish monitoring was shown (as below). Tim Salamunovich spent some time discussing his 33 year history of resident fish monitoring by electrofishing techniques on Putah Creek (b.ii. below). This item was informational only. One of the main messages is the more recent transition from mostly native fish upstream of i-80 and the mostly invasive fish below i-80. This is due to the colder water present upstream in i-80. Hasbrook commented that the Winters Putah Creek Nature Park restoration and channel changes now allow colder water to flow farther downstream. Of note, fish sampling below Mace Blvd has not occurred for the past 15 years, reflecting a shortage of baseline monitoring in that area of Putah Creek.

# 5. 2024 Putah Creek Monitoring Data Summit planning update

- SCWA's Putah Creek monitoring contractors meet annually to coordinate.
- 25+ years of data in a dozen programs
- Today ~\$750k per year from SCWA
- Increased importance to the Solano Project for the Voluntary Agreements (VA)
- SCWA Board wants RFP process for larger contracts (no automatic renewals)

Hansdale commented on the importance of monitoring for the VA process. The Streamkeeper commented that the Summit is used to emphasize foundational, long-term, monitoring on Putah Creek. SCWA funded monitoring is not about short-term research projects, although the monitoring data can be used for research. SCWA funded monitoring data are used for many purposes, include planning for flood control, water resources management, groundwater recharge studies, climate change investigations, real estate transactions, grant applications and evaluations, landscape scale fire management, construction projects, utility easements, and many others.

### 6. LPCCC Planning Subcommittee Update: PCWM - Putah Creek Water Management

Juliana Birkhoff from Ag innovation gave an update of PCWM activities. Ag Innovations is working on summarizing concerns, and ideas for solutions, to better sharing of water in Putah Creek. The plan is to go to the SCWA Board in June and to the LPCCC beforehand in May.
